SCR 122: Requesting The Board Of Education and State Librarian To Develop A Strategic Plan To Optimize The Use Of State Public Library Facilities.

The Hawaii State Public Library System (HSPLS) supports SCR 122 which requests the Board of Education (BOE) and State Librarian to develop a strategic plan to optimize the use of State public library facilities.

We have already started discussions with the Friends of the Library of Hawaii, other support groups, as well as other State, Federal and local agencies regarding alternate uses of our library facilities. We will soon be revising our HSPLS Strategic Plan for the BOE and will ensure this request is addressed and included as part of this plan.

We are constantly exploring expanding or optimizing our public service hours (including Saturday and evening hours) but with over 120 vacant positions and the need to negotiate with our public employee unions, our efforts have been very challenging.

Thank you for allowing us the opportunity to testify on this measure.
