Chairperson Tsuji and Members of the Committee:

Thank you for this opportunity to provide testimony on Senate Resolution No. 72/House Concurrent Resolution No. 135. The purpose of this resolution is to express support for the Department's efforts to stimulate the State's Agriculture industry, increase and diversify agricultural output, and promote food security. We are very grateful for your strong support of our new Agricultural Development and Food Security program and strongly support this resolution.

The goal of the Agricultural Development and Food Security program is to integrate programs in order to develop Hawaii's agriculture and food security. Hawaii's agriculture has transformed from sugar and pineapple to diversified agriculture and now faces such complexities as diversified export markets, increased pest pressure, global competitiveness, sustainability, food safety, food security and self-sufficiency.



To move the agriculture industry forward and meet the needs of the industry, will take a coordinated effort with the agricultural, transportation, and business industries, research organizations, and other federal and state agencies. Although the objectives appear simple and straightforward, the complexities can only be solved with cooperation and cohesive industry strategies and planning.

This program takes a holistic approach from farm-to-market, including subsystems which are not necessarily under the Department of Agriculture's (Department) purview, but critical to the development of agriculture. The overall concept overseen by the Department includes subsystems or subprograms such as but not limited to farm inputs, labor, infrastructure, biosecurity, food safety, sustainability, market development, and research and development.

Industry plays a prominent role in defining priorities; however, it is vital during this time of limited resources that the Department of Agriculture, the agriculture industries, the research institutions, and federal, state, county and private partnerships combine their resources and expertise due to the multitude of needs and complexity of issues. And yet, despite these complexities, all of our farmers and producers share these basic needs beyond infrastructure (land & water) and labor.

- Distinguish "Hawaii grown" in both local and export markets.
- Increase availability of improved cultivars to farmers.
- Assistance in pest management.
- Increase access to local, domestic, and international markets by removing trade barriers and improving access to quarantine treatments and resolving transportation issues.

We look forward to reporting on the progress of our initiatives.

I am Dean Okimoto, President of the Hawaii Farm Bureau Federation (HFBF). Organized since 1948, the HFBF is comprised of 1,800 farm family members statewide, and serves as Hawaii's voice of agriculture to protect, advocate and advance the social, economic and educational interest of our diverse agricultural community

HFBF is <u>in strong support</u> of SCR 135 which supports a framework for policy support of the agricultural industry.

Hawaii's State Constitution, State Policies as defined in HRS 226, various County General Plans and most recently the Governor's Platform of a New Day all speak to the importance of agriculture to Hawaii's future.

At the same time, efforts are often disconnected, with many pointing to the Department of Agriculture to carry out this mission. There may have been a time during abundant resources that such an order may have been reasonable. However, times have changed and the demands on the Department expanded. My name is Dave Arakawa, and I am the Executive Director of the Land Use Research Foundation of Hawaii (LURF), a private, non-profit research and trade association whose members include major Hawaii landowners, developers and a utility company. One of LURF's missions is to advocate for reasonable, rational and equitable land use planning, legislation and regulations that encourage well-planned economic growth and development, while safeguarding Hawaii's significant natural and cultural resources and public health and safety.

LURF appreciates the opportunity to express its **support of SCR 135**, and of the various agricultural stakeholder groups who defend the goals of viable agricultural operations, and the conservation and protection of agriculture, including important agricultural lands (IAL) in Hawaii. This resolution supports the need to establish an agricultural development and security program to improve the economic viability of the State's agricultural industry.

**SCR 135.** The intent of this Resolution is to support the establishment of an agricultural development and food security program that seeks to increase agricultural sustainability and improve the economic viability of the State's agriculture industry.

**LURF's Position.** Agricultural security is vital for the safe and secure production, processing, sale, distribution, importation and consumption of food products and agricultural commodities in Hawaii. This Resolution is intended to assist in the establishment of an agricultural development and food security program which is needed to help the State's agricultural industry meet food safety objectives and standards, and effectively increase the State's self-sufficiency, job opportunities and product exports, thereby diversifying the State's economy.

LURF understands that such a program is necessary on a local level in order that the State may, amongst other things, ensure that local food safety regulations and certifications conform to governmental and other uniform requirements and standards. This development of practices and standards of agricultural safety transparent to all is needed in Hawaii in order that members of the agriculture industry may voluntarily request certification by the DOA, verifying compliance with the standards. Adoption of such standards and policies will provide a practical

means for the State to support agriculture, and is necessary for the State to attain increased self-sufficiency and sustainability.

Based on the above, LURF **supports SCR 135**, and respectfully urges your favorable consideration of the Resolution.
