SCR 142 and SR 78 Relating to Continuing Education Requirements for Licensed Social

Workers

Chair Baker and Vice Chair Taniguchi and members of the Commerce and Consumer Protection Committee, I am Marty Oliphant, Executive Director of the National Association of Social Workers, Hawai'i Chapter. I am testifying in SUPPORT of SCR 142 and SR 78 Relating to Continuing Education Requirements for Licensed Social Workers.

The National Association of Social Workers, Hawaii Chapter (NASW), is working with the Department of Commerce and Consumer Affairs (DCCA) to develop Continuing Education Requirements for Licensed Social Workers in Hawai'i. We will continue to work with the DCCA with the intention to draft language for a legislative bill for the 2013 Legislative Session.

Continuing Education, in any profession, increases the knowledge base and the competency level of professionals. NASW views continuing education as an essential activity for ensuring quality social work services for clients. Social Workers are providing services in prevention, intervention, and treatment to an array of clients. Knowing the best practices and innovations in the field of social work will assist in protecting consumers in getting the best services as possible.

Hawai'i is 1 of 3 states that do not require Continuing Education for Social Workers. This Resolution will foster the work of the NASW and DCCA to bring about that change. As the Resolution states, NASW and DCCA are aware of relevant issues such as; 1) Ensuring that such requirements do not impose an undue burden on social work in rural areas of Hawai'i; 2) Using an established, widely recognized no-governmental entity to approve continuing education credits; and 3) Ensuring that the program to implement and monitor continuing education credits for licensed social workers is cost-neutral to the State. There are continuing education opportunities now for social workers and will continue to be available statewide, including rural areas, through in-person courses, webinars, and teleconferences.

We appreciate you exploring this need for Continuing Education relating the Licensed Social Workers. NASW is looking forward to our continued work with you and the DCCA.

My name is Dr. Noreen Mokuau, and I am writing today in support of SCR 142 and SR 78, two resolutions urging the Department of Commerce and Consumer Affairs and the National Association of Social Workers, Hawaii chapter, to develop continuing education requirements for licensed social workers.

As the dean of the Myron B. Thompson School of Social Work at the University of Hawai'i at Mānoa, I am committed to the concept of life-long learning. This is a value that is especially important for professional social workers because theories and skills within the field are constantly changing and improving. In order to be as effective as we can be, professional social workers must keep abreast with the latest knowledge and technologies available.

Furthermore, it has been a common problem within the social work field that good practitioners are frequently promoted into supervisory and administrative positions with little to no appropriate training. The School of Social Work has therefore received many requests over the years to offer training in these areas in order to improve the efficiency and quality of social services provided through both the private and public sectors.

As a means of meeting the needs and demands of the professional social work community, the MBT School of Social Work has increased its credit and non-credit course offerings in recent years. In addition to expanding the range of topics being covered – from practice theories and methodologies to clinical supervision and program management, the School has also expanded the formats through which the trainings are being delivered. So, while many of the trainings are being done in the traditional, face to face, manner, we are increasingly expanding our distance education options which utilize two-way video and internet based technologies for course delivery. Should continuing education credits be required for licensed social workers, we at the MBT School of Social Work are confident that we will be able to provide the training opportunities necessary to workers in the entire state – including neighbor islands and rural areas of Oahu.
