Purpose of Bill:

Requests the Department of Education and Board of Education to

institute a green Hawaii program within the public school system.

Department's Position:

The Department of Education (Department) supports, with modification, SCR 033,SD1 (sscr3043) that requires the Department to institute a "Green Hawaii" program within the public school system. Many of our schools are already implementing "Green" projects such as recycling plastic and aluminum cans, gardening, and engaging in other environmentally-friendly activities. Current Board Policy 6710, "Sustainability," directs that students become environmental stewards who will make sound decisions, behave responsibly, act constructively to maintain and improve the environment that supports and sustains all life on the Hawaiian Islands and the world.

We believe it is unnecessary, however, to require that all public and charter schools perform at least five "Green Hawaii" projects each school year as stated in this Resolution. The number of "Green" projects performed should be determined by the duration, magnitude, and complexity of the environmental experience and be appropriate to the educational curriculum and instruction for that school and grade level. A single project spread over a semester may benefit the environment more and have the appropriate educational content as several, smaller projects.

We request that the phrase "under which all public schools, including charter schools, are requested to perform at least five 'Green Hawaii' projects within each school year" be deleted from this Resolution.

Good Afternoon Madam Chairperson, Mister Chairperson and Committee Members. My name is Kaylee Baduria and I am a seventh grader at Ewa Makai Middle School but I am here on behalf of myself. I am strongly in support of the SCR 33 Resolution. This resolution is targeting the public school system as well as Charter Schools to implement at least five green initiatives into their current program. Taking care of the state of Hawaii is very important because combining the help of students and these green initiatives is a good way to educate our students and sustain Hawaii's natural resources.

This resolution states that all public schools, including charter schools, are required to apply a minimal amount of five green initiatives to their school starting in the year of 2015- 2016. Good Afternoon Madame Chair, Mister Chair, and Committee Members. My name is Rebekah Padua, and I attend Ewa Makai Middle School, but speaking on behalf of myself. I am here to support the Green Bill Resolution, which states that starting with the school year of 2015-2016, all public schools of Oahu, including public charter schools, are required to practice at least 5 Green Initiatives per school year. Although Ewa Makai Middle School is one of the very few public schools that engage in green projects, the monies for these projects does not have to come out of the school's budget. Grants can be written to non-profit foundations that may fund or supplement the Green Initiatives. There are already programs in place, of which I will name a few:

Kokua Hawaii Foundation is a non-profit organization that supports environmental activities in the state of Hawaii. They provide mini-grants for schools with a limitation of \$200 per classroom teacher and \$1,000 per school, per school year. Hawaii public schools practicing environmental Green Initiatives can request a mini-grant from the Kokua Hawaii Foundation, contacting them at grants@kokuahawaiifoundation.org.

The School Recycling Project Grant Program of the City and County of Honolulu provides financial assistance to support schools that intend to establish and implement a sustainable recycling project on campus with a limit of \$500 per school, per school year. The City Department of Environmental Services may also provide reservations for Hi-5 recycling bins to practice school-wide recycling. To enhance green practices and encourage students to continue them at home, teachers can also purchase additional educational materials.

Hawaii Nature Center, a recycling teaching partner, is an organization that provides environmental education to elementary students from the ages of 6 through 11.

Waikiki Worm, a recycling teaching partner, provides materials to sustain a healthy worm environment, which provides rich worm castings and vermicast for organic gardens.

The Green House, a sustainable learning center, provides programs, bringing standard-based and hands-on gardening education to elementary schools on Oahu. They provide workshops, as well as environmental Mini-Grants. Kokua Earth Action Projects (KEAP) assists Hawaii public school teachers to pay for supplies and training for environmental education services, providing \$200 per teacher and \$1,000 per school, per school year. Recycling Teaching Partners (RTP) Program, from the City and County of Honolulu, also provides grants of up to \$500 per school, per school year.

Grants and proposals can be written to support the funds for green projects in public schools. They can be written to any organization or non-profit foundation willing to provide equipment or money for the green practices. Contact information and grant forms can be found on their website. Therefore, it wouldn't be much of a problem having to find ways to "be green" at any public school, and will save the state money in the future.
