We find it Interesting that the bill does not make reference to a specific department to administer the regulation of colon hydrotherapists and colon hydrotherapy establishments. We can only speculate that DCCA would be the administering agency, but we do not wish to be presumptuous. However, if it is meant to be DCCA, pursuant Section 26H-6, Hawaii Revised Statutes, new regulatory measures being considered for enactment shall first be referred to the Auditor for a sunrise review. Therefore, if DCCA is to be the administering agency, we would support a sunrise study.
