Chair Fukunaga and Espero, Vice-Chair Wakai and Kidani, and committee members, thank you for the opportunity to submit comments on SCR 40, Proposed SD 1. The resolution is requesting to rename the prompt payment task force to the purchase of services procurement task force, and to extend its existence to December 31, 2012.

The resolution's listed tasks are not exclusive to the procurement process, but rather the way the services are planned, delivered and compensated.

For example, Page 3, lines 34-36, (1) "... issues from the initial contract phase through service delivery, and issues relating to payment..." is not a procurement issue. These are planning, contract management and payment issues.

Page 3, line 38-41, (2) "Identify areas that can be simplified and standardized between government agencies, . . ." is not a procurement issue. It is largely an operational and planning matter.

A more accurate and appropriate name is government contracting task force. "Government contracting" is more encompassing and includes planning, procurement, contract management and payment. These four activities are related but are distinctly different. The procurement process is limited in breadth and is the process used to procure provider(s) to deliver services to implement departmental policy decisions.

The State Procurement Office recommends that the name of the task force be changed to the government contracting task force. Thank you.
