My name is Robert Witt and I am executive director of the Hawaii Association of Independent Schools (HAIS), which represents 99 private and independent schools in Hawaii and educates over 33,000 students statewide.

HAIS supports SCR 48 and finds that the aspirations expressed in this measure are aligned with the goals of our own farm-to-school initiative, GROW HAWAII.

GROW HAWAII is a member of the Hawaii Farm to School and School Garden Hui and the O'ahu Farm to School Network, both of which are collaborative networks dedicated to addressing educational needs in agricultural sustainability by supporting existing school gardens, implementing new school gardens and integrating locally grown and made foods into cafeterias, snack programs, and after school programs with community involvement.

As SCR 48 states, many children in Hawaii have limited exposure to the wide range of locally produced healthy food available and do not know where the food they eat comes from or how their food was produced or prepared.

By supporting SCR 48, we will be able to continue to work with private, public and grassroots organizations to find solutions to food sustainability for the future of Hawai'i.

I am Amy Tousman, Registered Dietitian (RD) and President of the Hawaii Dietetic Association (HDA). HDA represents approximately 300 members throughout the state of Hawai'i, Guam and Saipan. I am writing to inform you that HDA is in strong SUPPORT of SCR48 which requests the Department of Health through its' Healthy Hawaii Initiative convene a School Gardens Task Force. I understand this legislation will allow the task force to determine how best to expand school gardens programs statewide.

ilso, I humbly submit to you the recommendation to include a representative from HDA on the task force. The RD is respected and recognized as the premier expert in food and nutrition. Local RDs have been involved in the development of school wellness policies and planning healthy menus. They have also been involved in innovative programs such as 'AINA in the Schools, Kaho'omiki Fun 5 Training and Kid Fit Programs

The American Diabetes Association of Hawaii estimates that one in two children born in the year 2000 in Hawaii will develop Type 2 Diabetes in their lifetime. Overweight and obese children are more likely to suffer chronic health conditions such as heart disease and diabetes as adults. Some of these children may not grow up to outlive their parents. These are alarming statistics

Many children in Hawaii do not have access to a broad range of local produce which offers a wide variety of healthy food options. The addition of locally grown produce in school meals will increase the exposure of our schoolchildren to nutrient rich fruits and vegetables of the highest quality. Produce shipped from the mainland or elsewhere loses its' nutritional value over the distance and time of travel. Farm to School Programs will allow our schoolchildren to see where their food comes from. This includes planting, harvesting, preparation and the presentation of a healthy meal. This will help to promote a lifetime of healthy eating. RDs have always believed and taught that a healthy lifestyle begins in the home and is fostered in our schools and in our communities.

For these reasons, I respectfully ask for your consideration of this measure and its passage.
