- 1 Department's Position: The Department of Health does not support this. The Department believes that
- 2 this resolution is unnecessary.
- 3 Fiscal Implications: There would be no fiscal impacts to the general fund.
- 4 Purpose and Justification: This resolution would encourage health care facilities and health care
- 5 providers in Hawaii to perform organ transplantation on patients with HIV, ARC, and AIDS.
- 6 The Department of Health believes that this resolution is unnecessary as HIV infected patients
- 7 are already able to obtain organ transplants. The decision regarding any transplant needs to be made by
- 8 health care providers in close consultation with their patients. People are now living longer and
- 9 relatively healthy lives with HIV/AIDS when viral replication is successfully suppressed with HIV
- 10 treatment regimes.
