
HARC has done tremendous research work for coffee, papaya, sugarcane, forestry, and is continuing to bring in new agricultural business to the state. They play a critical role in furthering the development of diversified agriculture. They also offer important and valuable historic information (i.e. soil conditions, rainfall, infrastructure, etc...) on the growing conditions of former sugarcane lands, which has shown positive effects for the production of new crops. As a private entity, HARC can move quickly on various research projects that are critical to many agribusinesses. It is important for the agricultural industry to have access to a private research organization in Hawaii to service their needs.

In today's world, our economy has become so globalized that it has changed the way we are able to process or manufacture products. Agriculture is no different as it has become difficult to process our own raw agricultural crops into value added products. If a Hawaii farmer wants to process his product into a higher value added product, he is often times forced to send it to the mainland as we lack the facilities to handle all types and quantities. The other challenge is the cost of transportation that often times discourage farmers to venture into this area.

Hawaii is losing millions of dollars as we lack the ability to process our own agricultural products. We need to be creative and find our niche market as it is difficult to compete with the global economy. An agricultural processing facility in Kunia will provide the farmers an opportunity to establish another market for their product.

The development of the Kunia Agriculture Processing and Sales Center is consistent with HARC's long term vision for their facility. HFBF strongly supports this resolution.

My name is Robert Dawson, and I am a founding member of Manulele Holdings, LLC. I wish give my strong support to SCR 67 SD1 in recognizing the efforts of the Hawaii Agricultural Research Center (HARC) in their efforts to revitalize the rural economy within the Kunia Village plantation site.

Manulele Holdings, LLC is the parent company of Manulele Distillers, LLC, Manulele Farms, LLC, and Manulele Foods & Products, LLC. Together, these companies will produce distilled spirits and food products in a farm-to-bottle operation within the proposed location. HARC strongly supports for SCR 67 SD1 recognizing the Center for its efforts to support agriculture through the development of an agriculture processing and sales center in Kunia Village.

We are truly excited about the development of this agricultural infrastructure. This could only be materializing because of the partnership we are forming with Pacific Gateway Center and visionary producers, Jason Brand and Robert Dawson.

Campbell Estate generously provided the Del Monte Kunia Village plantation site to HARC to maintain as infrastructure for agriculture on Oahu. HARC, a non-profit, has struggled with the enormous financial burden/opportunity that this property poses.

For the housing portion of this property it has partnered with the Rural Community Assistance Corporation, a partner that works with community to support development. Through its efforts it has been awarded USDA-Rural Development Agricultural Worker Housing loans and is waiting on the results of its application of low income housing tax credits from the Hawaii Housing Finance and Development Corporation.

For the business portion of this property several agricultural companies seeking security in long term leases have stepped up to renovated the agricultural accessory structures on the property. The retail store presents its own unique challenges; it is part of the historic character of the property and the demographics do not support its past use.
