Chair Chun Oakland, Chair Green and Committee Members:

AARP is a membership organization of people 50 and older with nearly 150,000 members in Hawaii. We are committed to championing access to affordable, quality health care for all generations, providing the tools needed to save for retirement, and serving as a reliable information source on issues critical to Americans age 50+.

AARP **supports** the intent of SCR 69 which appoints a Long-Term Care (LTC) Coordinator to coordinate programs, supports, and services to improve the quality of life for Hawaii's long-term care recipients; their caregivers; and their families.

AARP proposes that SCR 69 be amended as follows:

- Replace all references to Long-Term Care Coordinator with: Deputy Healthcare Transformation Coordinator. The appointment of a Deputy Healthcare Transformation Coordinator for LTC within the office of the Healthcare Transformation Coordinator will provide the authority and leadership needed to address the immediate LTC problems. The individual appointed to the Deputy Coordinator position will need executive level leadership skills, experience and ability to coordinate activities with the medical industry, LTC providers, and government agencies.
- 2. The Deputy Healthcare Transformation Coordinator shall establish a long-term care (LTC) task force to determine the feasibility of consolidating state LTC programs and functions under a single executive department or division, within the office of the Governor.

As reported by the Hawaii LTC Commission in its 2012 Report the primary problem is that "The LTC system in Hawaii is broken." One of the most glaring indicators that the system was broken was the Commission's early discovery that no one in the State Government could answer the most elementary of policy questions (*e.g.*, How many people in Hawaii have long-term care problems requiring caregiving?). After repeated attempts to find answers for this and other questions, the reason became obvious: No state leader was asking questions. What is more, no state leader is charged with the responsibility for asking such questions. The "system" is not just broken. Outside the Medicaid population, no "system" exists for Hawaii's population. There is only a no-man's land, a total void in government's role in long-term care (if any) for well over a million people.

Consolidation of the State's LTC system under single leadership in one agency, within the office of the Governor, will lead to streamlining the Hawaii LTC system, achieving more consistent

policymaking and enhanced economies of scale, and simplifying the consumer's experience. The consolidation of operations allows for increased flexibility, particularly when the consolidated agency has budgeting authority to shift funds among LTC services, to increase spending on home and community based services (HCBS), and to improve consumer access to those services. Consolidation, including global budgeting, by giving responsibility for the budget of all LTC programs to a single administrative unit would allow the financing to follow consumers through the system as their needs and preferences change over time.

SUBJECT: S.C.R. 99 - REQUESTING THE DEPARTMENTS OF HUMAN SERVICES AND HEALTH TO CONVENE A TASK FORCE TO DETERMINE WHEN AND UNDER WHAT CONDITIONS REPORTS OF ALLEGED VULNERABLE ADULT ABUSE, ALLEGED CHILD ABUSE, AND CONFIRMED CHILD ABUSE OR NEGLECT SHOULD BE EXPUNGED FROM THE DEPARTMENT OF HUMAN SERVICES CENTRAL REGISTRY

PURPOSE: This resolution requests the Departments of Human Services and Health to convene a task force to review the concerns arising from unsubstantiated and unconfirmed cases of child abuse and neglect, and adult abuse and neglect, as they relate to people seeking employment and to assess when and under what conditions reports of alleged vulnerable adult abuse, alleged child abuse and confirmed child abuse or neglect should be expunged from the Department of Human Services' central registry.

DEPARTMENT'S POSITION: The Department of Human Services appreciates

the intent of the proposed legislation to ensure the appropriate retention and AN EQUAL OPPORTUNITY AGENCY expungement of reports and records of maltreatment but this legislation is not needed. As we strive to ensure that only information on confirmed reports of abuse or neglect is shared under specific and appropriate circumstances, we must also strive to ensure that necessary and appropriate information is retained for the protection of children and vulnerable adults.

The Department's Child Welfare Service Branch (CWSB) follows the requirements of the Federal Child Abuse Prevention and Treatment Act (CAPTA). The retention of information on unsubstantiated reports for informational, data trending and investigatory purposes is allowed, with the provision that reports that are determined to be unsubstantiated are not made accessible to the general public nor are they allowed to be used for purposes of employment or background checks in cases determined to be unsubstantiated.

For the Department's Adult and Community Care Services Branch (ACCSB), there are no statutory provisions nor administrative rules authorizing the expungement of reports related to vulnerable adult abuse or neglect. It is essential that ACCSB retain the information gathered on alleged victims and perpetrators because many cases involve medical conditions for both victims and perpetrators that may worsen over time. Facts gathered in previously unsubstantiated or unconfirmed cases may become relevant in subsequent reports to DHS and may show evidence of a pattern of abuse or neglect.

Information from the Protective Services Central Registry for children or vulnerable adults may be released, upon consent of the individual, to prospective employers. If there is a confirmed or substantiated report of abuse on file, only the date of confirmation and the type of abuse involved are released. If there is no confirmed report of abuse on file, the information released will indicate "No record of confirmed abuse on file." No other information is released to the public.

The Department of Human Services is statutorily responsible for the child abuse and adult abuse registries.
