For more than 50 years, the East-West Center has been promoting better relations and understanding among the people and nations of the United States, Asia and the Pacific through cooperative study, research and dialogue. Established by the U.S. Congress in 1960, and incorporated by the State of Hawaii in 1975 (Act 82), the Center serves as a resource for information and analysis on critical issues of common concern, bringing people together to exchange views, build expertise, and develop policy options.

The Center is the recipient of \$1.7 million in federal funds for capital improvements and is requesting \$2.0 million from the State of Hawaii to meet its cost-matching requirements. The Center's facilities date from the 1960s and the buildings are severely out-dated and in need of improvements for safety and health purposes. The Center hosts thousands of participants, school children and visitors who would be impacted by the planned improvements with regards to their safety and health.

The Center has been able to obtain an appropriation from the federal government for \$1.7 million on the condition that it secures a matching amount from other sources. The Center is requesting \$2.0 million from the State of Hawaii to fulfill this matching requirement. It is projected that the projects will be completed by September 30, 2014. A list and brief description of the individual projects are attached.

Attachment C

The Center is situated on 21 acres in Manoa valley and is composed of six main buildings. The actual buildings affected by this capital improvement request are:

Imin Conference Center constructed in 1962
Hale Manoa – a 13-story dormitory constructed in 1962
Hale Kuahine – a 4-story dormitory constructed in 1962
Lincoln Hall – a 4-story dormitory constructed in 1962
John A. Burns Hall – a 4-story administrative building constructed in 1977

As mentioned, the student dormitories, conference facility and administrative building are host to thousands of participants, school children and visitors annually. Recent visitors have included President Obama and family, Secretary of State Clinton, the Dalai Lama and Nobel Peace Prize laureate Aung San Suu Kyi.

EWC Buildings Rehabilitation Schedule

Imin Conference Center Lanai Replacement - \$1 million

The concrete promenade surrounding the Imin Conference Center at Jefferson Hall comprises some 26,000 square feet of reinforced concrete laid over an impermeable membrane. This surface serves as an effective "roof" over various spaces in the Jefferson Hall basement including conference dining and meeting rooms; maintenance, mechanical and storage spaces; and repository for the Hamilton Library's collection of the Spark Matsunaga papers. Over the course of its 50+ year life the concrete and membrane have become compromised to the extent that numerous leaks have occurred in the basement spaces. While a piecemeal remediation has succeeded in arresting these leaks new ones continue to appear and can be expected to continue in the opinion of consultants retained to assess the situation. It is the opinion of these consultants that a comprehensive remedy is required which calls for the demolition and replacement of the existing surface and substrate. Safety is an issue as the leaks have occasionally reached mechanical rooms and lighting fixtures.

Hale Manoa Shower Stall Replacement - \$500,000

The Hale Manoa high rise dormitory is comprised of 48 residential clusters, each containing a bathroom with 2 shower stalls. These 50+ year-old facilities service up to 10 people daily, 365 days a year. In many of these units the lead pan designed to collect and direct water that penetrates the tile shower floor has failed with the result that water is leaking into units situated below the shower rooms and in some cases penetrating shower walls as well with water accumulating in adjacent corridors. These conditions create significant health and safety problems which must be addressed.

JAB Cooling Towers - \$500,000

The cooling towers, located on the roof of Burns Hall, are integral components of the building's air conditioning system. Installed about 13 years ago, these units are approaching the end of their service life. They are fabricated of galvanized metal and suffer from levels of corrosion that compromise their structural integrity. Failure of these units would either reduce air conditioning capacity or shut the system down completely.

Sprinkler Soffit Installation - \$500,000

In 2005 the EWC residence halls were retrofitted with fire suppression sprinkler systems. Fire code requires that exposed piping and sprinkler heads be enclosed in soffits. In order to minimize disruption to residents this portion of the project has been undertaken incrementally as rooms become vacant beginning in Hale Manoa which is 60% complete. Allocation of funds would permit the contractor to mobilize at Lincoln Hall which has a higher transitory and vacancy rate while also continuing to accomplish and accelerate incremental work at Hale Manoa and Hale Kuahine.

HM/Imin/JAB Elevators - \$200,000

Revisions to the fire code now require elevators to be equipped with automatic smoke detector activated recall and fireman's override capability. The elevator at Lincoln Hall is

in the process of being retrofitted with this function. The Center has six other elevators which also require this upgrade to current accepted safety standards.

JAB Elevators - \$400,000

The Burns Hall elevators were manufactured by Montgomery Elevator Co. which is now defunct. Its operations were acquired by the KONE Corporation of Finland in 1994. Over their nearly 30 year life, these elevators have proven to be operationally troublesome, increasingly so with age. In 2010, EWC retained a consultant to analyze their condition and make recommendations to ensure their viability. Those recommendations include replacement of motors, controllers and associated equipment and hardware.

Install Hale Kuahine Solar Hot Water System - \$120,000

The HK dormitory houses 120 students in 12 residential clusters. Hot water is currently generated for bathrooms and kitchens by two 56,000 BTU electrically-driven heat pumps. Engineering calculations project that a solar system will reduce electricity costs by approximately \$10,000 annually, helping with the Center's sustainability efforts.

Install "Smart" Irrigation Control System - \$200,000

Approximately 8 acres of the EWC campus is landscaped and requires irrigation by a network of pipes and sprinkler heads. This system is controlled by a series of timer devices which determine the frequency and duration of watering in various zones irrespective of atmospheric conditions. A "smart" controller system incorporates a network of sensors which activate individual components in response to detected moisture levels in the soil, thus conserving water and minimizing waste.

Replace Dormitory (HM & HK) Lounge Furnishings - \$280,000

Hale Manoa and Hale Kuahine dormitories incorporate a variety of communal spaces which include study lounges and dorm gathering areas. These heavily used spaces are furnished with an assemblage of antiquated chairs, sofas and tables – many of which are original furnishings dating back to the construction of the buildings in 1961. While these furnishings have been maintained through on-going repairs and cannibalization they are undeniably and very obviously well beyond their intended life and less appropriate to a modern graduate study environment.

The capital improvement projects will be overseen by the Director of Administration with coordination by the Center's Facilities Management, Housing and Imin Conference Center units (see organizational chart).
