The Healthy Mothers, Healthy Babies Coalition of Hawaii (HMHB) is a local nonprofit organization dedicated to improving Hawaii's maternal, child and family health though collaborative efforts in public education, advocacy and partner development. HMHB believes in equal access to quality health care; a collective voice to facilitate change; eliminating health disparities among all populations; cultural competence and respect for diversity; and education to encourage healthy choices.

HMHB currently provides the following services:

- A free MothersCare phone line designed to help pregnant women, new mothers and their families find the information and resources necessary to have a healthy pregnancy, birth and baby.
- Quarterly trainings for perinatal support service providers throughout the state of Hawaii on various topics directly relating to improving the health of pregnant women, new mothers and their infants
- Coordination of quarterly Perinatal Advocacy Network meetings designed to increase awareness of perinatal issues in Hawaii, expand advocacy efforts for perinatal health issues and legislative actions, and increase networking and partnerships among state perinatal health providers
- Creation and distribution of various culturally-appropriate educational materials for Hawaii's pregnant women, mothers and their families (including topics such as safe sleep/SIDS prevention, Fetal Alcohol Spectrum Disorder, Post-Partum Depression, breastfeeding, and nutrition, as well as a "healthy & hapai" educational pregnancy calendar to help women keep track of their prenatal appointments and to find resources for a healthy pregnancy)
- Maintaining a dynamic online pregnancy and perinatal resource directory searchable by both type of service and location (providers add/edit their organization's information pending HMHB approval)
- Performing two needs assessments per fiscal year relating to maternal and child health in the state of Hawaii to help steer both community efforts as well as the

- Hawaii State Department of Health's efforts to improve maternal and child health in Hawaii
- Updating families and providers on current recalls, maternal and child health news, and local resources/events in the maternal and child health community through social media including Facebook and Twitter, and through promotion of the Text4Baby program
 - 2. The goals and objectives related to the request;

To reduce the risk and prevalence of Sudden Unexpected Infant Death (SUID) and Sudden Infant Death Syndrome (SIDS) in the state of Hawaii, **Healthy Mothers Healthy Babies Coalition of Hawaii**, partnering with the **Parent Line** and **Safe Sleep Hawaii**, has designed a comprehensive "**Hawaii Cribs For Kids**" program. This program provides culturally appropriate, family-based safe sleep education to high-risk, low-income families and a free GRACO Pack N Play® crib and fitted sheet to families who cannot otherwise afford a safe place for their baby to sleep.

HMHB is requesting funds to support and expand our comprehensive family-inclusive safe sleep education, the first and only program of its kind in Hawaii, to reach more qualified families and prevent needless infant deaths.

HMHB will follow up with participants when their baby turns three months old, and again when their baby turns one year old. Mothers/families who need additional information or support, will be referred to the Parent Line, HMHB's partner organization, for both phone support and possible enrollment into the Parent Line Home Visiting Program. The Home Visiting Program offers additional in-home support relating to safe sleep and other parenting and safety-related topics.

3. The public purpose and need to be served;

While the overall deaths from SIDS have declined both nationally and in Hawaii since the AAP's recommendations for all babies to be placed on their backs to sleep, sleep-related deaths from other causes including suffocation, entrapment and asphyxia have increased. As a result, sleep-related deaths remain the number one cause of infant deaths after the first month of age.

Sudden Unexpected Infant Death (SUID) is defined as the sudden and unexpected death of an infant less than one year of age whose cause of death is not immediately obvious. If the SUID cannot be explained after thorough investigation, it is usually attributed to Sudden Infant Death Syndrome (SIDS). More than 4,500 infants die of SUID every year in the United States, with approximately half being attributed to SIDS. SIDS is the leading cause of death among infants between the age of one month and one year and the third leading cause of infant mortality overall in the United States. In Hawaii, SIDS accounts for 41% of all post-neonatal deaths in the state.

Similar safe sleep programs throughout the United States have yielded favorable results in preventing SIDS/SUID; an outcome that can be replicated through this unique, one-of-a-kind program in Hawaii.

4. Describe the target population to be served; and

Working with prenatal case managers and social workers who serve a large portion of the Native Hawaiian/Part Hawaiian, Samoan, Black and Other Pacific Islander populations, all of which show increased risk factors for SUID, we have carefully identified qualified recipients for the education and crib assistance.

Currently, many babies in these higher-risk populations in Hawaii do not have safe sleeping environments. The following facts are from the 2009-2010 Hawaii Pregnancy Risk Assessment Monitoring System (PRAMS) survey, indicating a substantial number of risk factors for unsafe sleep environments.

- Sleep Environment: **only 34.2% of babies in Hawaii usually sleep in an environment that meets all of the AAP's recommendations for a safe sleep environment.** Nearly two-thirds (65.8%) usually sleep in an environment with at least one of the following risk factors:
 - o 19.6% sleep with pillows
 - o 31.3% sleep with bumper pads
 - o 19.6% sleep with plush blankets
 - o 4.3% sleep with stuffed toys
 - o 19.3% do not sleep in a crib or portable crib
 - o 14.7% do not sleep on a firm or hard mattress
- Sleep Position: Approximately one-quarter (24.3%) of babies in Hawaii are most often laid to sleep in high-risk sleep positions (either on their side or stomach)
- Bed-Sharing: one-third (33.9%) of Hawaii's infants "always" or "often" sleep in the same bed with another family or household member. An additional 19.9% of Hawaii's infants "sometimes" do.
 - 5. Describe the geographic coverage.

This program will take place on the island of Oahu, with plans to expand coverage throughout all islands in subsequent years.

Prenatal case managers and social workers from Kokua Kalihi Valley Comprehensive Health Services, Waianae Coast Comprehensive Health Services, the Queen Emma Clinic and Kapiolani Medical Center for Women and Children are currently being trained on how to screen for participants, and are submitting applications to HMHB for potential participants.

These four partner clinics were chosen because they serve the populations that show the greatest risk for SUID/SIDS based on sleep environment risk factors (sleeping with pillows, bumper pads, plush blankets, or stuffed toys; not in a crib or portable crib; and not on a firm or hard mattress) and have a high percentage of WIC participation

(another risk factor for unsafe sleeping environments and SUID). These clinics also serve a large portion of the Native Hawaiian/Part Hawaiian, Samoan, Black and Other Pacific Islander populations, all of which show increased risk factors for SUID.

II. Service Summary and Outcomes

The Hawaii Cribs for Kids Program is the first ever of its kind in the state of Hawaii. Referrals will be accepted from prenatal case managers and social workers at Kokua Kalihi Valley Health Center, Waianae Coast Comprehensive Health Center, Queen Emma Clinic and Kapiolani Medical Center, all of which serve high-risk low-income women and their families.

Each of the four referring clinics will also serve as a site for the one-hour safe sleep class required for all participants. After completion of the class, participants will be given a GRACO Pack N Play travel crib to take home with them.

HMHB's Program Manager is responsible for the execution of the Hawaii Cribs for Cribs Program, with oversight from HMHBs Executive Director. The Program Manager is responsible for accepting referrals and determining eligibility for the program, as well as working with Safe Sleep Hawaii and the Parent Line to develop, refine and administer the educational portion of the program.

The Program Manager will instruct the one-hour class with participants, and follow up with each family at three months and one year postpartum to determine the information retention and whether participants are effectively applying safe sleep practices.

Referrals will be open for four weeks at a time, and will close two weeks before the next class. All participants must provide HMHB with the necessary income documentation. Priority will be given to those families in greatest need, and with the highest number of risk factors for SUID.

Currently, HMHB has the capacity to serve 67 families over the next year, accepting between eight and 10 families every six weeks, with the intention to expand the program to serve more families, as budget allows. The following 2013 timeline has

been implemented, with the expectation to triple the number of enrollees, should we have funding available.

There are three parts to evaluating the quality of the results and outcomes of the program:

- Knowledge
 - Participants will be given a test on safe sleep practices prior to, and immediately following, completion of the educational class.
 - Questions pertain to general awareness and preventative measures to create a safe sleeping environment. Participants will be also asked to identify any unsafe or hazardous items in a sample crib.
 - This test is designed to measure participants' change in knowledge regarding safe sleep practices and will measure the effectiveness of the class in increasing knowledge of safe sleep practices and SIDS prevention.
- Retention and behavior change
 - Participants will be asked the same questions (as in the pre/post-test) regarding safe sleeping practices at the three-month and one-year follow up, and will also be asked about their safe sleep practices.
 - o This will measure the participants' knowledge retention and will identify if the class was successful in creating behavior changes (if parents continued to follow safe sleep practices). This also provides the opportunity to reinforce safe sleep information.
- SUID/SIDS Rates
 - At three months and one year, the health status of the baby will be monitored to track the SUID/SIDS rates among participants.
 - o This will measure the effectiveness of the program in preventing SUID/SIDS.

Each of these locations is fully ADA compliant, as required by law.



 - b) Complies with all applicable federal and state laws prohibiting discrimination against any person on the basis of race, color, national origin, religion, creed, sex, age, sexual orientation, or disability;
 - c) Agrees not to use state funds for entertainment or lobbying activities; and
 - d) Allows the state agency to which funds for the grant or subsidy were appropriated for expenditure, legislative committees and their staff, and the auditor full access to their records, reports, files, and other related documents and information for purposes of monitoring, measuring the effectiveness, and ensuring the proper expenditure of the grant or subsidy.
- 2) The applicant meets the following requirements pursuant to Section 42F-103, Hawai'i Revised Statutes:
 - a) Is incorporated under the laws of the State; and
 - b) Has bylaws or policies that describe the manner in which the activities or services for which a grant or subsidy is awarded shall be conducted or provided.
- 3) If the applicant is a non-profit organization, it meets the following requirements pursuant to Section 42F-103, Hawai'i Revised Statutes:
 - a) Is determined and designated to be a non-profit organization by the Internal Revenue Service; and
 - b) Has a governing board whose members have no material conflict of interest and serve without compensation.

Pursuant to Section 42F-103, Hawai'i Revised Statutes, for grants or subsidies used for the acquisition of land, when the organization discontinues the activities or services on the land acquired for which the grant or subsidy was awarded and disposes of the land in fee simple or by lease, the organization shall negotiate with the expending agency for a lump sum or installment repayment to the State of the amount of the grant or subsidy used for the acquisition of the land.
