## **Application for Grants and Subsidies**

### I. Background and Summary

#### 1. A brief description of the applicant's background;

Ka Waianu o Hāloa is a small non-profit that functions on the East side of Maui in the rural community of Ke'anae, in the district of Ko'olau. Ninety nine percent of the 200 population in Ke'anae and Wailuanui are Native Hawaiian. It is over a one hour drive on a long winding road over bridges and through isolated forests from the town of Kahului and another hour drive to Hānā town. The closest schools are one hour to Haiku and another hour to the closest town in Hānā. Here the village has homesteads of multigenerational families that have lived there since pre-contact.

The nonprofit was formed to bring education back into the community through programs, outreach and ultimately starting a Hawaiian Culture Focused Charter School in the community. Utilizing the community resources in knowledge, traditions, and natural resources Ka Waianu o Hāloa has brought free educational and fun programs to the community for all ages but focusing on the children of the area and surrounding communities. Due to the seclusion of the community there has been a lack of programs and extracurricular activities for both young and old.

Ka Waianu o Hāloa will renovate the Ke'anae School facility so that the community may utilize the school for the enrichment of the community itself. The nonprofit envisions the school as a neutral meeting and gathering place for the entire community wither it's with the programs, meetings, exercise, learning, or the Charter School. Many small events have already been hosted there. The Ke'anae School is an old historic site which has weathered the rainy and the humid conditions. The building has termite and water damage which causes majority of the repairs needed. This historic site will be a safe learning environment for the community and school, to do so it needs to be brought up to state and county codes.

The community needs a library and/or media center which will create a place for technology and research. Providing enrichment programs for the youth in sports, cultural activities, literacy, tutorial, healthy lifestyles, sustainable agricultural techniques, and a center to meet the community needs.

A certified kitchen to feed the students also creates a place for farmers to process and directly sell to the market. The certified kitchen will be a key resource to perpetuate their traditional farming practices in this district. Currently the school does not have a certified kitchen to feed the students. In recent history the lunches of all the students were being delivered from the Hānā School campus over one hour away.

The school would be open to residents and the outlying communities of the East side. The school is also designed to be based on real life application and hands on learning. The nonprofit has been maintaining the school for two years now and has started the plans for major renovation and new buildings for the much needed space. At this time the community meets in one of the small rooms in the facility or under tents set in the lawn. A large basketball court is available for the community to use on only sunny days. The lawn and upkeep of the school has been done by volunteers.

## II. Service Summary and Outcomes

The plans for the school are currently in the hands of the architect. Planning has started but design and final plans are needed prior to permitting and construction. Upon meeting with the architect the buildings we desired and the renovations needed were noted and will be drawn up to our specifications. The funding will help us to complete the plans and design of the school. In the plans are three new rooms each with a different use. One room will be an additional classroom for the school use, one will be the media room and library which will be open for the community to use, and another will be a school and community meeting or conference room. Many of the meetings held at the school are too small to offer enough space for community members so the conference room will provide adequate space for such meetings and classes. The nonprofit is putting together a committee for the planning for obtaining media equipment and library books for the rooms, furniture for each room, and funding for each. Each room will reflect the different need in the school and community.

The school also has a need for the certified kitchen and lunch hall. Currently the school does not have the adequate kitchen to feed the students once the school is in session. All meals in prior times were trucked over an hour from Hānā to feed the students. The community has a great need for the kitchen also because there is no other community kitchen which can be rented within over an hour drive from Ke'anae. The kitchen can be rented by the community to be used to process their farm goods for sale legally to market. This will bring some economic change to the residents of the community and provide funding for the school to support the upkeep of the facility space and program. Other uses for the kitchen and hall would be for community gatherings like a community center would be if there was one currently in the community.

There is a lack of parking for the school so when there are events cars need to park along the main highway through the community and this can sometimes be dangerous and inconvenient.

To approach our goal to be a "green" school and community use facility we would like to install photovoltaic panels to provide energy for the facilities.

These panels will conserve natural resources and help us to become a self-sustainable school. The panels will save the school money in the future and help the nonprofit utilize funds for other uses.

The existing facility is a historic site which has been weathering the elements in the area for a long time. Many parts of the building need to be brought up to code and to ADA standards prior to the school opening. Much of the termite and water damage has gone unattended to and needs to be addressed promptly to save the building. Among some of the repairs is a complete repair of the bathrooms and floors, water rot in some of the rooms, rotten floors and railings, doors and other renovations.

We are currently working with the DOE to develop the plans and design and will continue moving forward with trying to acquire the funding needed for the construction. With the different funders we hope to take the construction in phases. Once the planning and design is completed we will be able to more adequately plan out each phase and the needed funding for each phase.

- We plan to have our project manager outline each detail and need for all phases and deadlines.

The Keanae school facility is a National Historic Site and it sits in the center of the community. This school is currently leased by Ka Waianu o Hāloa since 2011. The school has three small rooms and historically has been the only school in the community of Keanae. The school has been one of the last remaining one room school houses in the state. The last of the students were taken from the school and forced to travel to Hana to attend school there in 2005. The school since then has stayed vacant until Ka Waianu o Hāloa leased the school and

started clean up.

Since late 2011 the nonprofit has hosted numerous gatherings and educational programs at the school. The very first KWOH Summer Enrichment Program was held over the summer of 2012 at the school. This school provides a space for the community to use and the nonprofit to host educational programs. KWOH plans to continue the educational programs for both young and old. The most current classes were for adults with tips on saving energy in their own households.

The school also is being redecorated so the community will have a place to borrow books from the school library which consist of only a few hundred books but still allow for enough space for classroom use. The school has been vacant for so long that there has been much neglect.

Many items are not up to code yet but we plan to remedy that. The railings, ramps and bathrooms all need to be renovated to provide adequate ADA compliances. We need the proper funding so we may bring the school up to code and compliant along with repairing the school so it will be safe for students and community members.
