I. Background and Summary

1. A brief description of the applicant's background;

The Pacific Education Center (PEC) was incorporated on October 4, 2012 in Hawaii as a Non-Profit Educational Institution. This new program is similar to the Pacific Training Center at Chaminade University program that operated from April 2004 to June 2006, and was successful in providing OSHA Training Institute (OTI) certified training in Hawaii. The PEC program was established by a group of Safety and Health Professionals, Company Executives and Educational leaders to provide Quality Hawaii based Environmental Health, Occupational Safety and Public Safety Training to Companies, Organizations and Individuals in Hawaii and the Pacific Rim. Our objective is to provide training in a cost effective manner that gives every employer the opportunity to get their employees properly trained. We have negotiated a Memorandum of Understanding (MOU) with the OSHA Training Institute at Chabot-Las Positas Community College District, Dublin, California, to be their provider of the OTI certified Training in the State of Hawaii and the Pacific Rim. Our program includes providing free Small Business Safety Seminars Statewide, as well as supporting the Hawaii Occupational Safety and Health Division (HIOSH) by providing free training to their staff. We also provide free training to Hawaii Veterans who can not afford to pay for required health and safety training they need to obtain employment. The PEC provided our first OSHA course from January 3 to January 11, 2013.

2. The goals and objectives related to the request;

The primary goal and objective for this request is to utilize the funds to bring Building 1890 at Kalaeloa (the former Residential Fire Station and Child Development center) to operational status for use by the PEC. The PEC can then focus our revenues to providing Free Small Business Safety Seminars as well as our regular training sessions.

The PEC currently rents classroom space from other providers and organizations which is very costly. We have identified Building 1890 at Kalaeloa as a logical location to house our program. We are in negotiations with Hunt Development to

obtain the property rent free for the first two years of our occupancy, but we must accept the building in an as is condition. Hunt Development is willing to sponsor the lease for the program for the first two years but will not extend any funds to restore the building to a functional status. The facility has not been utilized or operational since the late 1990s and needs to have all utilities re-established or repaired. If the Legislature approves the Grant the funds will solely be used to bring the facility to a useable condition.

3. The public purpose and need to be served;

Under the current economic conditions Small Business statewide are struggling. Small Business owners and managers are now limiting their budgets solely to cover direct operational costs. What we in the Health and Safety Profession recognize is that Small Businesses many times do not include in their budgets provisions for keeping a Safety and Health professional on staff or providing for the required Safety and Health training for their employees. Because of this "Safety Knowledge Gap" many Business owners, managers and their employees are not be fully aware of safety and health regulatory requirements. Employees are then allowed to work in Dangerous or Hazardous conditions that can cause injury, illness and even death. Training Employers as well as their employees in Safety and Health Management is the most cost effective method to build an strong safety culture that helps to protect both the employees from work related illness and injury, and the employer from Regulatory violations and increased workers compensation costs.

Prior to the Lingle Administration, the Hawaii Occupational Safety and Health Division's (HIOSH) Consultation and Training Branch provided free monthly safety program management courses to the public. Currently HIOSH is in a rebuilding mode after the State's OSHA program was downgraded to 18E status by Federal OSHA. HIOSH has not provided public training for several years. The Pacific Education Center would like to support the HIOSH mission and rebuilding effort by making available Statewide, monthly, one and two day Small Business Seminars in Safety and Health Management. We also will provide open seats in our OTI training courses at no charge to HIOSH for their Inspectors and Consultants. Lastly we plan to provide free training to Hawaii Veterans who can not afford to pay for required health and safety training they need to obtain employment.

4. Describe the target population to be served; and

Small Businesses, Government Agencies, Veterans and the General Public.

5. Describe the geographic coverage.

Through out Hawaii on all major Islands.

II. Service Summary and Outcomes

The Scope of work for the requested funds is to re-establish Electrical Power, Air Conditioning, Fire Sprinkler and Fire Alarm systems to Building 1890 in Kalaeloa. This will include reconnection of the building to the high power overhead lines and instillation of a new Transformer by the Naval Facilities and Engineering Command. Testing and R&R of the Buildings Electrical Panels and switches by a Licensed Electrician. Purchase and Instillation of new 16 ton Air Conditioning Compressor unit and reconnection to the building and air conditioning system. Testing and repair of the existing Fire Sprinkler and Fire Alarm Systems.

2. Provide a projected annual timeline for accomplishing the results or outcomes of the service;

The scope of work on the building will be completed within 60 days of the Grant disbursement.

3. Describe its quality assurance and evaluation plans for the request. Specify how the applicant plans to monitor, evaluate, and improve their results; and

All work on the building will be in compliance with State of Hawaii, and City and County of Honolulu building codes (i.e. International Building Code, Uniform Plumbing Code, National Electrical Code, and Uniform Fire Code). All work will be verified by the properly leaser as meeting the above named requirements prior to occupancy and utilization of the building. Permits will be obtained if required.

4. List the measure(s) of effectiveness that will be reported to the State agency through which grant funds are appropriated (the expending agency). For our educational programs, the Pacific Education Center's Board of Directors and Executive Staff have extensive experience Providing Educational and Training Programs in the state of Hawaii. Our Executive Director, Mr. Raymond

L. Welch, MS, CSP, STS, was the Director of the Pacific Training Center at Chaminade University from April 2004 to June 2006. During that time the program provided 22, three and four day, OTI courses statewide with an average of 23 attendants per course. Prior to that Mr. Welch was the Environmental and Occupational Safety and Training Specialist with the University of Hawaii at Manoa. In this position Mr. Welch was responsible for the development and delivery of Environmental and Safety Training, UH system wide, to Staff, Students, Educators and Researchers. On our Board of Directors is Michael Fassiotto PhD, Assistant to the Provost for Graduate Services, Chaminade University. Dr. Fassiotto has an extensive resume directing Higher Educational programs in the state and is a primary advisor for the program.

For the oversight of bringing Building 1890 to operational status, Mr. Welch as well as several of our Board of Directors have experience overseeing Construction projects. Mr. Welch served as the Quality Control/Environmental and Safety Manager for Defense Base Services Inc. (DBSI) for the current \$4.5 million US Fish and Wildlife Base Operations and Services Contract for Midway Atoll, National Wildlife Refuge. Mr. Welch's duties on this contract included oversight of compliance with construction technical specifications and contractual obligations for the contractor. In addition from 2001 to 2003 Mr. Welch managed a \$100,000 Supplemental Environmental Project for Chaminade University and completed the project on time and on budget.

B. Facilities

Building 1890 in Kalaeloa was built by the Navy in 1983 as a Community and Child Development Center. The Facility was redesigned and upgraded to a Single Engine Residential Fire Station in the early 1990's and decommissioned by the Navy during the closure of Barbers Point Navel Air Station. The building was disconnected from Electrical Utilities Lines and has been unoccupied and boarded up since decommissioning in the late 1990's. The Building with parking encompasses 6257 square feet with a reception area, multi use classrooms, office spaces, lounge, and two sets of Male and Female Rest Rooms. The Building was redesigned to meet ADA requirements in 1993 when the facility became a Fire Station. The facility has ADA compliant access ramps from the Parking area to the doors. There are two separate Male and Female Rest Rooms with shower units that have Handicapped access and Hand Rails. The building has Visual and Auditory Fire Signals and the egress doors have panic push bars.
