

## A BILL FOR AN ACT

MAKING EMERGENCY APPROPRIATIONS FOR THE OPERATIONS OF THE OFFICE  
OF THE LIEUTENANT GOVERNOR.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. This Act is recommended by the governor for  
2 immediate passage in accordance with section 9 of article VII of  
3 the Constitution of the State of Hawaii.

4           SECTION 2. The recent appointment of the former lieutenant  
5 governor to the United States Senate and subsequent succession  
6 of a member of the legislature to the position of lieutenant  
7 governor resulted in unanticipated additional costs for the  
8 2012-2013 fiscal year.

9           The purpose of this Act is to appropriate funds as an  
10 emergency appropriation for costs associated with the operations  
11 of the lieutenant governor's office.

12           SECTION 3. There is appropriated out of the general  
13 revenues of the State of Hawaii the sum of \$126,690 or so much  
14 thereof as may be necessary for fiscal year 2012-2013 to be used  
15 by the office of the lieutenant governor (LTG 100).

16           The sum appropriated shall be expended by the office of the  
17 lieutenant governor for the purposes of this Act.



1 SECTION 4. There is appropriated out of the general  
2 revenues of the State of Hawaii the sum of \$85,654 or so much  
3 thereof as may be necessary for fiscal year 2012-2013 to be used  
4 by the sheriff (PSD503) for the purpose of providing protection  
5 to the lieutenant governor.

6 The sum appropriated shall be expended by the department of  
7 public safety for the purposes of this Act.

8 SECTION 5. There is appropriated out of the general  
9 revenues of the State of Hawaii the sum of \$105,000 or so much  
10 thereof as may be necessary for fiscal year 2012-2013 to be used  
11 for public works - planning, design, & construction (AGS221) for  
12 costs related to the operations of the office of the lieutenant  
13 governor.

14 The sum appropriated shall be expended by the department of  
15 accounting and general services for the purposes of this Act.

16 SECTION 6. This Act shall take effect upon its approval.
