A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF TAXATION SPECIAL ENFORCEMENT SECTION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Act 134, Session Laws of Hawaii 2009, is 1 2 amended by amending section 13 to read as follows: 3 "SECTION 13. This Act shall take effect upon its approval; 4 provided that: The amendments made to section 235-20.5, Hawaii 5 (1)6 Revised Statutes, by this Act shall not be repealed 7 when section 235-20.5, Hawaii Revised Statutes, is reenacted on January 1, 2011, pursuant to section 8 of 8 Act 206, Session Laws of Hawaii 2007; and 9 Sections 231-F, 231-J, 231-K, 231-L, 231-M, 231-N, 10 (2) 231-O, and 231-P, Hawaii Revised Statutes, in section 11 2 of this Act shall take effect on July 1, 2009[; and 12 13 (3) This Act shall be repealed on June 30, 2014, and 14 section 235-20.5, Hawaii Revised Statutes, shall be reenacted in the form in which it read on the day 15 prior to the effective date of section 8 of Act 206, 16 Session Laws of Hawaii 2007; provided further that 17

1	sections 231-1, 237 9, and 237-12(b), Hawaii Revised
2	Statutes, shall be reenacted in the form in which they
3	read on the day prior to the effective date of this
4	Act]."
5	SECTION 2. Statutory material to be repealed is bracketed
6	and stricken. New statutory material is underscored.
7	SECTION 3. This Act shall take effect upon its approval.
