## A BILL FOR AN ACT

RELATING TO THE DESIGNEES FOR THE DIRECTORS OF THE DEPARTMENTS OF COMMERCE AND CONSUMER AFFAIRS, OF HEALTH, OF HUMAN SERVICES, AND OF LABOR AND INDUSTRIAL RELATIONS FOR THE BOARD OF DIRECTORS OF THE HAWAII HEALTH INSURANCE EXCHANGE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. Section 435H-4, Hawaii Revised Statutes, is 1
- amended by amending subsection (b) to read as follows: 2
- 3 "(b) The membership of the board shall reflect geographic
- diversity and the diverse interests of stakeholders including 4
- consumers, employers, insurers, and dental benefit providers. 5
- 6 The director of commerce and consumer affairs or the director's
- 7 designee, the director of health or the director's designee, the
- 8 director of human services or the director's designee, and the
- 9 director of labor and industrial relations or the director's
- designee shall be ex-officio, voting members of the board. 10
- 11 The director of commerce and consumer affairs, the director
- 12 of health, the director of human services, and the director of
- labor and industrial relations may select a designee for a 13
- 14 specified meeting or meetings. Such selection of the designee
- shall be submitted in writing to the board of directors prior to 15
- or at the meeting in which the designee will serve." 16
