## A BILL FOR AN ACT

MAKING APPROPRIATIONS FOR COLLECTIVE BARGAINING COST ITEMS.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 17 SECTION 8. Funds appropriated or authorized by this Act
- 18 that are not expended or encumbered by June 30, 2014, and June
  - 19 30, 2015, of the respective fiscal years, shall lapse as of
  - 20 those dates.
- 21 SECTION 9. This Act shall take effect on July 1, 2013.
