BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Act 89, Session Laws of Hawaii 2009, is amended 1 2 as follows: 3 1. By amending section 1 to read: "SECTION 1. Section 200-37, Hawaii Revised Statutes, is 4 5 amended by amending subsection (c) to read as follows: 6 "(c) No person shall operate a thrill craft in the waters 7 of the State, except: 8 In areas and during time periods designated by the 9 department; (2) Through areas designated by the department to serve as 10 11 avenues for the ingress and egress of thrill craft 12 between the areas designated under paragraph (1) and 13 the shore; Authorized government personnel conducting operations 14 (3) 15 approved by the department; [ex] (4)Authorized film production permit holders conducting 16 operations approved by the department[-]; or **17**

- 5 SECTION 2. The department of land and natural resources
- 6 shall adopt rules in accordance with chapter 91, Hawaii Revised
- 7 Statutes, to implement this Act.
- 8 SECTION 3. The chairperson of the board of land and
- 9 natural resources shall report to the legislature no later than
- 10 twenty days prior to the convening of the regular session of
- 11 2014 on the status of the adoption of rules pursuant to section
- 12 2 of this Act.
- 13 SECTION 4. Statutory material to be repealed is bracketed
- 14 and stricken. New statutory material is underscored.
- 15 SECTION 5. This Act shall take effect upon its approval.
