A BILL FOR AN ACT

MAKING APPROPRIATIONS FOR PUBLIC EMPLOYMENT COST ITEMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 **PART I**

2 SECTION 1. There is appropriated from the general revenues
3 of the State of Hawaii to the legislative agencies indicated
4 below, the following sums or so much thereof as may be necessary
5 for fiscal biennium, 2013-2014 and 2014-2015, to fund cost
6 adjustments authorized by chapter 89C, Hawaii Revised Statutes,
7 for legislative officers and employees excluded from collective
8 bargaining:

1 SECTION 2. Funds appropriated by this part shall be
2 allotted to the head of the respective legislative agencies for
3 expenditure for the purposes of this part.

4 PART II

5 SECTION 3. Cost items and cost adjustments provided in
6 this Act for any legislative officer or employee whose
7 compensation is paid, in whole or in part, from federal,
8 special, or other funds shall be paid wholly or proportionately,
9 as the case may be, from the respective funds.

10 SECTION 4. Funds appropriated or authorized by this Act
11 that are not expended or encumbered by the end of the fiscal
12 year for which the appropriation or authorization is made shall
13 lapse as of that date.

14 SECTION 5. This Act shall take effect on July 1, 2013.
