A BILL FOR AN ACT

RELATING TO THE PENAL CODE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. Section 706-620, Hawaii Revised Statutes, is
2	amended to	o read as follows:
3	"§70	6-620 Authority to withhold sentence of imprisonment.
4	A defenda	nt who has been convicted of a crime may be sentenced
5	to a term	of probation unless:
6	(1)	The crime is first or second degree murder or
7		attempted first or second degree murder;
8	(2)	The crime is a class A felony, except class A felonies
9		defined in chapter 712, part IV, and by section
10		707-702;
11	(3)	The defendant is a repeat offender under section
12		706-606.5;
13	(4)	The defendant is a felony firearm offender as defined
14		in section 706-660.1(2); [or]
15	(5)	The crime involved the death of or the infliction of
16		serious or substantial bodily injury upon a child, an
17		elder person, or a handicapped person under section
18		706-660.2[.] <u>; or</u>

1	(6) The crime is cruelty to animals where ten or more pet
2	animals were involved under section 711-1108.5 or
3	<u>711-1109.</u> "
4	SECTION 2. Section 711-1109, Hawaii Revised Statutes, is
5	amended by amending subsection (4) to read as follows:
6	"(4) Cruelty to animals in the second degree is a
7	misdemeanor $[-]$, except where the offense involves ten or more
8	pet animals in any one instance which is a class C felony."
9	SECTION 3. This Act does not affect rights and duties that
10	matured, penalties that were incurred, and proceedings that were
11	begun before its effective date.
12	SECTION 4. Statutory material to be repealed is bracketed
13	and stricken. New statutory material is underscored.
14	SECTION 5. This Act shall take effect upon its approval.
