Dear President Kim, Speaker Souki, and Members of the Legislature:

Re: Senate Bill No. 614, S.D. 1, H.D. 2, C.D. 1

Senate Bill No. 614, S.D. 1, H.D. 2, C.D. 1, entitled "A BILL FOR AN ACT RELATING TO PUBLIC WORKS OF ART" will become law without my signature, pursuant to Section 16 of Article III of the State Constitution.

The purpose of this bill is to require the Comptroller and the State Foundation on Culture and the Arts to commission artwork in honor of both the late United States Senator Daniel K. Inouye and the late United States Representative Patsy T. Mink and to appropriate \$250,000 from the Works of Art Special Fund for the commission of the artwork.

The late Senator Daniel K. Inouye and the late Representative Patsy T. Mink are both worthy recipients of the honorable memorials that this bill seeks to create. However, I am concerned about the use of Works of Art Special Fund for design and consultation of these memorials rather than their actual construction.

## A BILL FOR AN ACT

RELATING TO PUBLIC WORKS OF ART.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to honor the memory
- 2 of the late United States Senator Daniel K. Inouye and the late
- 3 United States Representative Patsy T. Mink and to use their
- 4 examples to inspire current and future generations.
- 5 SECTION 2. (a) The comptroller and the state foundation
- 6 on culture and the arts shall commission a permanent, three-
- 7 dimensional work of art to portray the life, vision,
- 8 accomplishments, impact, and legacy of the late United States
- 9 Senator Daniel K. Inouye so as to properly honor his memory and
- 10 to utilize his example as an inspiration for current and future
- 11 generations.
- 12 (b) The state foundation on culture and the arts, at the
- 13 earliest opportunity, shall issue a call for design entries;
- 14 provided that the design shall include but is not limited to a
- 15 likeness of Daniel K. Inouye at some stage of his life.
- 16 (c) Notwithstanding any other law or rule to the contrary,
- 17 the winning design shall be selected from among the design
- 18 entries, in consultation with the state foundation on culture

- 1 thereof as may be necessary for fiscal year 2014-2015 for the
- 2 comptroller and state foundation on culture and the arts to
- 3 commission art pursuant to sections 2 and 3 of this Act.
- 4 The sums appropriated shall be expended by the department
- 5 of accounting and general services for the purposes of this Act.
- 6 SECTION 5. This Act shall take effect on July 1, 2013.
