
A BILL FOR AN ACT

MAKING AN APPROPRIATION FOR PUBLIC EMPLOYMENT COST ITEMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 PART I

2 SECTION 1. There are appropriated or authorized from the
3 sources of funding indicated below to the department of budget
4 and finance, departmental administration and budget division
5 (BUF 101), the following sums or so much thereof as may be
6 necessary to fund for fiscal biennium 2013-2015, the Hawaii
7 employer-union health benefits trust fund costs and other cost
8 adjustments contained in the agreement negotiated with the
9 exclusive bargaining representative of collective bargaining
10 unit (1):

21 adjustments provided in this Act for any officer or employee
22 whose compensation is paid, in whole or in part, from federal,



1 special, or other funds shall be paid wholly or proportionately,
2 as the case may be, from the respective funds.

3 SECTION 14. Funds appropriated or authorized by this Act
4 that are not expended or encumbered by the end of the fiscal
5 year for which the appropriation or authorization is made, shall
6 lapse as of those dates.

7 SECTION 15. This Act shall take effect on July 1, 2013.
