A BILL FOR AN ACT

RELATING TO AGING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. Section 349-4, Hawaii Revised Statutes, is amended to read as follows:
- 3 "\$349-4 Policy advisory board for elder affairs[-];
- 4 <u>lifetime honorary kupuna.</u> (a) There shall be a policy advisory
- 5 board for elder affairs, appointed by the governor under section
- 6 26-34. The board shall advise the director in, but not limited
- 7 to, the following areas:
- 8 (1) The identification of issues and alternative9 approaches to solutions;
- 10 (2) The development of position statements and papers;
- 11 (3) Advocacy and legislative actions; and
- 12 (4) Program development and operations.
- 13 The board shall consist of not less than twenty-one nor more
- 14 than twenty-nine members, a majority of whom are over sixty
- 15 years of age and who shall be selected on the basis of their
- 16 interests and knowledge in and their ability to make
- 17 contributions to the solution of problems relating to aging, and
- 18 shall include at least one member from the county of Hawaii, one HB1258 HD1 HMS 2013-2156



- 1 member from the county of Maui, one member from the county of
- 2 Kauai, and one member from the city and county of Honolulu.
- 3 There shall be nine members who shall serve as ex officio
- 4 members and shall be chosen from among the heads of the
- 5 following state agencies which provide services or programs
- 6 affecting elders: health, human services, education, labor and
- 7 industrial relations, University of Hawaii, transportation, the
- 8 state retirement system, the office of consumer protection, and,
- 9 by invitation, the Hawaii representative of the United States
- 10 Department of Health, Education and Welfare. Of the non ex
- 11 officio members, one-third of the members shall be appointed for
- 12 the term of four years, one-third for the term of three years,
- 13 and one-third for the term of two years; and thereafter the
- 14 terms of office of each member shall be four years. The members
- 15 shall serve without compensation, but shall be paid their
- 16 necessary expenses in attending meetings and carrying out the
- 17 responsibilities of the board. The chairperson shall be elected
- 18 annually from the nongovernmental members of the board. There
- 19 shall be not less than twelve meetings of the board each year.
- 20 (b) The policy advisory board for elder affairs may honor
- 21 a non ex-officio member by voting to award the member a lifetime

Allows Policy Advisory Board for Elder Affairs to honor a non ex-officio member with an honorary kupuna title; requires Governor to consider honorary title when considering honoree's reappointment; authorizes Governor to reappoint honoree for continued terms over the honoree's lifetime.
