A BILL FOR AN ACT

RELATING TO MILITARY SERVICE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. In 2005, the legislature passed Act 21, which
- 2 provided for a Hawaii medal of honor to express the deep
- 3 appreciation and gratitude of the people of Hawaii to the loved
- 4 ones of members of the military who sacrificed their lives in
- 5 defense of our nation and its freedom. Since 2006, there have
- 6 been more than two hundred forty recipients of the Hawaii medal
- 7 of honor.
- 8 The purpose of this Act is to clarify the eligibility
- 9 requirements for the Hawaii medal of honor.
- 10 SECTION 2. Section 5-22, Hawaii Revised Statutes, is
- 11 amended as follows:
- 12 1. By amending its title and subsection (a) to read:
- "[+]\$5-22[+] Hawaii medal of honor. (a) The Hawaii medal
- 14 of honor may be awarded on behalf of the people of the State of
- 15 Hawaii to an individual who has been killed in action[7] while:
- 16 (1) Engaged in an action against an enemy of the United
- 17 States;

20		residents of Hawaii and were activated into service at
21		the time they were killed in action;

1	(2)	Members of the United States military reserves who
2		were legal residents of Hawaii and were activated into
3		service at the time they were killed in action;
4	(3)	Members of the regular United States armed forces who
5		were:
6		(A) Legal residents of Hawaii at the time they were

8		(B) Stationed in Hawaii by a proper order of the
9		United States Department of Defense at the time
10		they were killed in action; and
11	(4)	Members of the Hawaii national guard[7] or United
12		States military reserves who were activated into
13		service, or members of the regular United States armed
14		forces, who:
15		(A) Attended a public or private educational
16		institution in Hawaii at some period during their
17		lives; and
18		(B) Were killed in action."

21	SECT	ION 4. This Act shall take effect upon its approval.
