
A BILL FOR AN ACT

RELATING TO CAPITAL IMPROVEMENT PROJECTS FOR THE BENEFIT OF THE
FIFTEENTH REPRESENTATIVE DISTRICT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The following sums, or so much thereof as shall
2 be sufficient to finance the projects listed in this Act, are
3 hereby appropriated out of the general revenues of the State of
4 Hawaii for fiscal year 2013-2014:

5 1. To be expended by the department of accounting and
6 general services:

7	A.	Kauai Judiciary Complex, Kauai	
8		Plans, design, and construction of frame and	
9		implementation of a photovoltaic system to be	
10		installed at the Kauai Judiciary Complex.	
11		Plans	\$250,000
12		Design	\$250,000
13		Construction	\$2,500,000
14		Total funding	\$3,000,000

15 2. To be expended by the department of agriculture:
16 A. Lihue Civic Center, Piikoi Building, Kauai



1 For use by the Kauai County Farm Bureau, for plans and
 2 design for the renovation and reconstruction of the
 3 Lihue Civic Center, Piikoi Building for use as the new
 4 Kauai Food Production Center.

5 Plans and Design \$300,000

7 3. To be expended by the department of education:

8 A. Kauai high school, Kauai

9 Construction for an automotive paint booth.

10 Construction \$250,000
 11 Total funding \$250,000

12 4. To be expended by the department of land and natural
 13 resources:

14 A. Pualoke baseyard, Kauai

15 Plans, design, and construction for renovation, repair
 16 and maintenance improvements of existing garage
 17 utilized by the department for storage of supplies and
 18 equipment.


