A BILL FOR AN ACT

RELATING TO THE JAPANESE AMERICAN EXPERIENCE IN HAWAII.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that a Nisei Veterans 2 Legacy Center would preserve, perpetuate, and share the legacy of 3 the Americans of Japanese ancestry who served in the United 4 States armed forces in World War II. Such a center would provide 5 research and educational programs, outreach efforts, and displays for residents and visitors. The establishment of a Nisei 6 7 Veterans Legacy Center would create a facility dedicated to 8 researching, preserving, and interpreting the history of 100th 9 Infantry Battalion, 442nd Regimental Combat Team, Military 10 Intelligence Service, and the 1399th Engineer Construction 11 Battalion to develop deeper understandings of their unique place 12 in Hawaiian, American, and global history. 13 A Nisei Veterans Legacy Center would curate materials and 14 artifacts to preserve and perpetuate the legacy of the Nisei 15 soldiers of World War II who fought loyally and valiantly against 16 the Axis powers on the European and Pacific battlefields, while

- 4 battlefield experiences and sacrifices contributed to political
- 5 leadership, social movements, and social transformation in Hawaii
- 6 and the United States.
- 7 Locating a Nisei Veterans Legacy Center in West Oahu would
- 8 complement academic and research programs offered at the
- 9 University of Hawaii, such as the Center for Labor Education and
- 10 Research's Labor Archives and the Henry Guigni film collection.
- 11 The Honouliuli Internment Camp is a major historical site
- 12 located on property currently owned by Monsanto in West Oahu.
- 13 The United States National Park Service, Japanese Cultural Center
- 14 of Hawaii, University of Hawaii-West Oahu, the State of Hawaii,
- 15 Monsanto, and other stakeholders are working to preserve and
- 16 share the existing remnants of the internment camp, with a
- 17 planned educational center and memorial. In 2012, the
- 18 legislature established a Honouliuli advisory group to develop
- 19 recommendations to help develop this site with government and
- 20 private resources, and the group will continue to meet through
- 21 January 1, 2014.



The purpose of this Act is to make an appropriation for the 1 planning, design, and construction of a center in West Oahu that 2 would incorporate a Nisei Veterans Legacy Center and a Honouliuli 3 Internment Camp Educational Center. The legislature intends for a 4 5 matching source of private or public funds to be secured prior to the release of the appropriation. 6 7 There is appropriated out of the general SECTION 2. revenues of the State of Hawaii the sum of \$500,000 or so much 8 9 thereof as may be necessary for fiscal year 2013-2014 for the 10 planning, design, and construction of a Nisei Veterans Legacy 11 Center and a Honouliuli Internment Camp Educational Center. 12 The sum appropriated shall be expended by the department of land and natural resources for the purposes of this Act; 13 14 provided that no moneys appropriated under this Act shall be 15 expended unless matched by grants or donations from public or 16 private sources. For the purposes of this Act, the value of inkind donations from private sources may be included for the 17 18 purpose of calculating the amount of matching funds; provided 19 that the director of finance shall first verify the value of any 20 such donation.

1 SECTION 3. This Act shall take effect on July 1, 2013.
