#### A BILL FOR AN ACT

MAKING APPROPRIATIONS TO PROVIDE FOR THE EXPENSES OF THE LEGISLATURE, THE AUDITOR, THE LEGISLATIVE REFERENCE BUREAU, THE OMBUDSMAN, AND THE ETHICS COMMISSION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. There is appropriated out of the general 2 revenues of the State of Hawaii the sum of \$7,464,744 or so much 3 thereof as may be necessary to the senate for the following 4 expenses: 5 (1) The sum of \$6,477,244 for defraying any and all session and nonsession expenses of the senate up to and including June 30, 2014, including the 2013 7 8 regular session, twenty-seventh legislature of the State of Hawaii, and pre-session expenses and the 9 10 expenses of any committee or committees established 11 during the interim between the 2013 and 2014 regular 12 sessions;
  - (2) The sum of \$900,000 for defraying the expenses of the legislative information system for cost items such as hardware, software, consultants, installation,

14		session and nonsession expenses of the house of	
15		representatives up to and including June 30, 2014,	
16		including the 2013 regular session, twenty-seventh

19		committees established during the interim between the	
20		2013 and 2014 regular sessions;	
21	(2)	The sum of \$688,424 for defraying the expenses of the	
22		legislative information system for cost items such as

4	that have been or will be incurred; and		
5	(3) The sum of \$87,500 for defraying the cost of the		
6	legislative broadcasting program to pay for the

8	of legislative proceedings.		
9	The sum appropriated in this section shall be expended by		
10	the house of representatives.		
11	SECTION 3. Payment of expenses of the senate during the		
12	interim between the 2013 and 2014 regular sessions shall be made		
13	only with the approval of the president of the senate, and		
14	payment of expenses of the house of representatives during the		
15	interim between the 2013 and 2014 regular sessions shall be made		
16	only with the approval of the speaker of the house of		
17	representatives.		
18	SECTION 4. Before January 15, 2014, the senate and the		
19	house of representatives shall each have their accounts audited,		
20	and a full report of the respective audits shall be presented t		
21	the senate and to the house of representatives convening on		
22	January 15, 2014.

5	the auditor.				
6	SECTION 7. There is appropriated out of the general				
7	revenues of the State of Hawaii the sum of \$2,550,828 or so much				
8	thereof as may be necessary to the office of the auditor during				
9	fiscal year 2013-2014 to be deposited into the audit revolving				
10	fund established pursuant to section 23-3.6, Hawaii Revised				
11	Statutes.				
12	SECTION 8. There is appropriated out of the audit				
13	revolving fund the sum of \$6,000,000 or so much thereof as may				
14	be necessary to the office of the auditor during fiscal year				
15	2013-2014 for the office to conduct or complete its audit				
16	functions as provided by law.				
<b>17</b> .	The sum appropriated in this section shall be expended by				
18	the auditor.				
19	SECTION 9. There is appropriated out of the general				
20	revenues of the State of Hawaii the sum of \$2,983,970 or so much				
21	thereof as may be necessary to the legislative reference bureau				

for defraying the expenses of the legislative reference bureau

- 3 The sum appropriated in this section shall be expended by

- 5 SECTION 10. There is appropriated out of the general
- 6 revenues of the State of Hawaii the sum of \$1,017,875 or so much
- 7 thereof as may be necessary to the office of the ombudsman for
- 8 defraying the expenses of the office during fiscal year
- 9 2013-2014.
- 10 The sum appropriated in this section shall be expended by
- 11 the ombudsman.
- 12 SECTION 11. There is appropriated out of the general
- 13 revenues of the State of Hawaii the sum of \$849,531 or so much
- 14 thereof as may be necessary to the office of the state ethics
- 15 commission for defraying the expenses of the office during
- 16 fiscal year 2013-2014.
- 17 The sum appropriated in this section shall be expended by
- 18 the state ethics commission.
- 19 SECTION 12. Except for moneys in the audit revolving fund,
- 20 as of the close of business on June 30, 2014, the unexpended or
- 21 unencumbered balance of any appropriation made by this Act shall
- 22 lapse into the general fund.
