BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

Section 8-1, Hawaii Revised Statutes, is 1 SECTION 1. 2 amended to read as follows: Holidays designated. The following days of each 3 4 year are set apart and established as state holidays: 5 The first day in January, New Year's Day; The third Monday in January, Dr. Martin Luther King, Jr., 6 7 Day; The third Monday in February, Presidents' Day; 8 The twenty-sixth day in March, Prince Jonah Kuhio 9 10 Kalanianaole Day; The Friday preceding Easter Sunday, Good Friday; 11 The last Monday in May, Memorial Day; 12 The eleventh day in June, King Kamehameha I Day; 13 14 The fourth day in July, Independence Day; 15 The third Friday in August, Statehood Day; The first Monday in September, Labor Day; 16 17 The eleventh day in November, Veterans' Day; The fourth Thursday in November, Thanksgiving Day; 18 HB LRB 13-0440-1.doc

The twenty-fifth day in December, Christmas Day; 1 All election days, except primary and special election 2 days, in the county wherein the election is held; provided that 3 if the office of elections establishes an election by mail 4 process for all registered voters of the State, election days 5 shall no longer be considered a state holiday under this 6 7 section; Any day designated by proclamation by the President of the 8 United States or by the governor as a holiday." 9 SECTION 2. A collective bargaining agreement that is 10 11 executed: Pursuant to chapter 89, Hawaii Revised Statutes; and 12 (1) (2) After the office of elections establishes an election 13 by mail process for all registered voters of the 14 15 State: shall reflect a reduction in the number of paid holidays to 16 which a public employee who is subject to the collective 17 bargaining agreement may be entitled in a calendar year in which 18 a general election occurs, as established under this Act; 19 provided that the loss of the general election holiday shall not 20 be considered a negotiable item for collective bargaining 21 22 purposes.
