### A BILL FOR AN ACT

RELATING TO AGRICULTURE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that coffee is the fourth 2 largest agricultural crop in the State and is a highly valued commodity in Hawaii's economy. Coffee plantations cover 3 4 approximately eight thousand acres of land in the State and generate total farm revenues of approximately \$30,000,000. 5 6 addition to its value as an agricultural commodity, interest in 7 coffee farms as part of the agricultural tourism experience is 8 growing. According to the Hawaii agricultural statistics 9 service, the value of the agricultural tourism industry, with 10 one hundred and twelve farms earning income from agricultural tourism activities, was measured at \$38,800,000, in 2006. 11 12 Coffee farmers participating in the agricultural tourism 13 industry have been able to increase coffee revenues by selling directly to visitors to their farms, thus increasing the role 14 that coffee plays in agricultural tourism, which is a growing 15 16 part of the State's economy.
- The legislature also finds that, in recent years, the

- 1 crops worldwide, has infested coffee crops in the Kona and South
- 2 Kona regions. The infestation of coffee farms by the coffee
- 3 berry borer threatens to dismantle Hawaii's entire coffee
- 4 industry because of the nature and speed of the infestations.
- 5 Currently, it is estimated that over ninety per cent of coffee
- 6 farms in the Kona region are affected by the coffee berry borer,
- 7 and it is likely that every farm in the region will be
- 8 experiencing some degree of infestation soon. Infestations and
- 9 secondary effects of infestation have drastically reduced the
- 10 yield of coffee trees and adversely impacted the quantity and
- 11 prices of coffee from the Kona region.
- 12 The legislature also finds that ongoing efforts to control
- 13 the damage to crops are critical, now that the coffee berry
- 14 borer is present in Hawaii. It can also be expected that the
- 15 coffee berry borer will eventually spread to other regions and
- 16 counties of Hawaii where coffee is farmed. Methods to combat
- 17 the coffee berry borer are used effectively in other coffee-
- 18 growing regions of the world. However, farmers in Hawaii need
- 19 to be educated about these methods and how to effectively apply
- 20 them. In addition, the costs of the required supplies and labor
- 21 to implement these methods can be financially prohibitive for
- 22 smaller coffee farms in the State.

1 The legislature further finds that because of Hawaii's 2 unique terrain, and the preponderance of small-sized farms with 3 an aging population of farmers, the existing labor-intensive 4 methods of combating the coffee berry borer are more challenging 5 to implement in Hawaii than in other regions of the world. 6 that reason, research is needed to develop new methods 7 appropriate for Hawaii's coffee farms, including those that 8 could reduce the cost of labor necessary to control the coffee 9 berry borer. The legislature finds that it is essential to take immediate action to develop methods to combat the coffee berry 10 11 borer and to mitigate the future impacts to other coffee-12 producing regions in the State. The purpose of this Act is to appropriate funds for the 13 14 control and containment of the damage caused by the coffee berry 15 borer and to conduct research for the purpose of developing new 16 methods of the prevention and treatment of infestations. 17 SECTION 2. There is appropriated out of the agricultural development and food security special fund of the State of 18 19 Hawaii the sum of \$500,000 or so much thereof as may be 20 necessary for fiscal year 2013-2014 and the same sum or so much 21 thereof as may be necessary for fiscal year 2014-2015 to the United State Pacific Basin Agricultural Research Center to 22



- 1 research and develop methods for the prevention and treatment of
- 2 coffee berry borer beetle infestations.
- 3 The sums appropriated shall be expended by the department
- 4 of agriculture for the purposes of this section.
- 5 SECTION 3. There is appropriated out of the agricultural
- 6 development and food security special fund of the State of
- 7 Hawaii the sum of \$330,000 or so much thereof as may be
- 8 necessary for fiscal year 2013-2014 for a grant-in aid pursuant
- 9 to chapter 42, Hawaii Revised Statutes, to the coffee berry
- 10 borer task force to fund efforts to control and mitigate the
- 11 damage from the coffee berry borer infestation in Hawaii;
- 12 provided that no funds shall be expended unless matched by
- 13 moneys from either private or other government sources.
- 14 The sum appropriated shall be expended by the university of
- 15 Hawaii for the purposes of this section.

16 SECTION 4. This Act shall take effect on July 1, 2013.
