A BILL FOR AN ACT

RELATING TO THE COLORECTAL CANCER SCREENING PILOT PROGRAM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 The legislature finds that of cancers affecting SECTION 1. 2 men and women, cancer of the colon and rectum, also known as 3 colorectal cancer, is the second leading killer in the United States. According to the National Cancer Institute, in 2007, 4 5 142,627 people in the United States were diagnosed with, and 53,219 people died from, colorectal cancer. Based on rates from 6 7 2006 through 2008, 5.08 per cent of men and women born today 8 will be diagnosed with colorectal cancer during their lifetime. 9 Since colorectal cancer almost always develops from precancerous 10 polyps in the colon or rectum, screening tests are an easy and 11 effective method to find precancerous polyps and detect 12 colorectal cancer in its early stages. 13 The legislature also finds that a screening program will 14 increase detections of any cancer at an early state, which in 15 turn improves chances for survival and decreases mortality rates. With the success of the Hawaii comprehensive breast and 16 cervical cancer control program, established by the legislature 17

- 1 legislature further finds that this program is a model of an
- 2 effective approach to increasing the number of screenings and
- 3 early detection of colorectal cancer.
- 4 The purpose of this Act is to:
- 5 (1) Establish a two-year Hawaii colorectal cancer
- 6 screening pilot program using the Hawaii comprehensive
- 5 7 breast and cervical cancer control program as a model;
- 8 and
- 9 (2) Appropriate funds for the pilot program.
- 10 SECTION 2. (a) There is established the Hawaii colorectal
- 11 cancer screening pilot program, to be administered by the
- 12 department of health in collaboration with the department of
- 13 human services, to facilitate the early detection of colorectal
- 14 cancer and to assist individuals who have been diagnosed with
- 15 colorectal cancer through the Hawaii colorectal cancer screen
- 16 pilot program.
- 17 (b) Under the Hawaii colorectal cancer screening program,
- 18 the department of health shall:
- 19 (1) Educate, train, and improve the skills of health care
- 20 professionals, including allied health professionals
- 21 and lay health educators, in the detection and

1		management of colorectal cancer through the
2		professionals' participation in the pilot program;
3	(2)	Educate women and men regarding the risks associated
4		with colorectal cancer; and
5	(3)	Provide outreach to individuals who are at greater
6		risk for colorectal cancer.
7	(c)	Screening and treatment shall be available to high
8	risk popu	lations and individuals fifty years or older,
9	regardles	s of an individual's eligibility for medicaid coverage.
10	(d)	Under the Hawaii colorectal cancer screening program,
11	the depar	tment of human services shall provide to persons
12	eligible	for medicaid state-funded medical assistance, as
13	available	, to:
14	(1)	Provide screenings for colorectal cancer to
15		individuals who are:
16		(A) Fifty years of age or older; or
17		(B) Under the age of fifty years and at high risk for
18		colorectal cancer;
19	(2)	Provide appropriate case management and referrals for
20		medical treatment of individuals screened through the
21		pilot program; and

1	(3)	Ensure, either directly or through coordination or an
2		arrangement with health care providers or programs,
3		the full continuum of care for screened individuals,
4		including appropriate follow up for abnormal tests,
5		diagnostic services, therapeutic services, treatment
6		of detected cancers, and management of unanticipated
7		medical complications.
8	(e)	The department of health shall submit a report to the
9	legislatu	re no later than twenty days prior to the convening of
10	the 2014	and 2015 regular sessions on the expenditure of all
11	funds for	the Hawaii colorectal cancer screening pilot program.
12	SECT	ION 3. There is appropriated out of the general
13	revenues	of the State of Hawaii the sum of \$200,000 or so much
14	thereof as may be necessary for fiscal year 2013-2014 and the	
15	same sum	or so much thereof as may be necessary for fiscal year
16	2014-2015	for the Hawaii colorectal cancer screening pilot
17	program.	
18	The	sums appropriated shall be expended by the department
19	of health	for the purposes of this Act.
