# A BILL FOR AN ACT

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 304A, Hawaii Revised Statutes, is	
2	amended b	y adding a new section to part IV to be appropriately
3	designated and to read as follows:	
4	" <u>§304A-</u> Hawaii institute of marine biology; stewardship	
5	of aquacu	lture and marine protected areas. The Hawaii institute
6	of marine	biology may establish a research program to work in
