## A BILL FOR AN ACT

RELATING TO UNIFORM MAINTENANCE ALLOWANCE.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. The legislature finds that the uniform  
2 maintenance allowance for enlisted personnel established in 1967  
3 is more than covered by the increased tax exemption for enlisted  
4 personnel enacted in Act 197, Session Laws of Hawaii 2004.  
5 Additionally, the legislature finds that most modern military  
6 service uniforms are made of wash and wear fabric that no longer  
7 requires dry cleaning, making the uniform maintenance allowance  
8 unwarranted.

9           The purpose of this Act is to repeal the uniform  
10 maintenance allowance for enlisted personnel.

11           SECTION 2. Section 121-41, Hawaii Revised Statutes, is  
12 repealed.

10       SECTION 3. Statutory material to be repealed is bracketed  
 11 and stricken.

12       SECTION 4. This Act shall take effect on July 1, 2112.
