A BILL FOR AN ACT

RELATING TO STATE FUNDS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that the national and
2	global economic crisis that began in the second half of 2008 has
3	caused significant economic problems in numerous industries in
4	the State, including the airline, cruise ship, tourist, and
5	construction industries. Mass layoffs have been reported by an
6	increasing number of Hawaii businesses statewide, from the
7	agricultural sector to the medical-services sector. Difficult
8	economic times and declining tax revenues have resulted in
9	budget cuts for all state services.
10	The current and impending situation jeopardizes the safety
11	net of basic human services, health, and education needs for
12	Hawaii's residents and families. While all of Hawaii's
13	residents will be affected by the situation, gap group families
14	and families closest to the poverty line will suffer the most.
15	The purpose of this Act is to appropriate moneys from the
16	general fund to maintain the levels of programs determined to be
17	essential to education, public health, and public welfare.
