A BILL FOR AN ACT

RELATING TO PUBLIC SAFETY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that public safety is 2 unduly put in jeopardy when a general contractor is allowed to 3 act as a specialty contractor in an area in which the general contractor is not licensed to operate. The Hawaii supreme court 4 5 held that a general engineering or building contractor is 6 prohibited from doing any work that requires it to act as a 7 specialty contractor in an area the general contractor is not 8 licensed to operate. Okada Trucking Co., Ltd. v. Board of Water 9 Supply, 40 p.3d 73, 83 (2002). 10 The legislature finds that the purpose of chapter 444, 11 Hawaii Revised Statutes, entitled "Contractors", is as stated in 12 section 444-4(2), "the protection of the general public." The 13 protection of the general public is best achieved through the 14 requirement of specialty licenses for specialty work. 15 specialty license ensures that basic industry standards for each 16 specialty craft are met because the contractor must demonstrate **17** its qualifications in this regard to obtain a specialty license. 18 Thus, the possibility of substandard work is minimized.

- 3 SECTION 5. Section 444-9, Hawaii Revised Statutes, is
- 4 amended to read as follows:
- 5 "\$444-9 Licenses required. No person within the purview
- 6 of this chapter shall act, or assume to act, or advertise, as
- 7 general engineering contractor, general building contractor, or
- 8 specialty contractor without a license previously obtained under
- 9 and in compliance with this chapter and the rules and
- 10 regulations of the contractors license board. A general
- 11 engineering or general building contractor shall not perform
- 12 incidental and supplemental work for which it is not,
- 13 automatically or otherwise, duly licensed and for which it lacks
- 14 the requisite specialized skill to undertake."
- 15 SECTION 6. New statutory material is underscored.
