# A BILL FOR AN ACT

RELATING TO PESTICIDES.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The purpose of this Act is to better address
2	the potential public health and environmental issues related to
3	restricted use pesticides by requiring the online publishing of
4	certain restricted use pesticide records, reports, or forms.
5	SECTION 2. Chapter 149A, Hawaii Revised Statutes, is
6	amended by adding a new section to be appropriately designated
7	and to read as follows:
8	"§149A- Pesticide use; posting online. (a) The
9	department shall publish on its website the public information
10	contained in all restricted use pesticide records, reports, or
11	forms submitted to the department, except those records,
12	reports, or forms required by the department for restricted use
