BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. Section 26-6, Hawaii Revised Statutes, is

11	(2)	Report to the governor and to each regular session of

14	(3)	Administer the state risk management program;
15	(4)	Establish and manage motor pools;
16	(5)	Manage the preservation and disposal of all records of
17		the State;

	(0)	ondercake the program or centralized engineering and
2		office leasing services, including operation and
3		maintenance of public buildings, for departments of
4		the State;
5	(7)	Undertake the functions of the state surveyor;
6	(8)	Establish accounting and internal control systems;
7	(9)	Provide centralized computer information management
8		and processing services, coordination in the use of
9		all information processing equipment, software,
10		facilities, and services in the executive branch of
11		the State, and consultation and support services in
12		the use of information processing and management
13		technologies to improve the efficiency, effectiveness,
14		and productivity of state government programs; and
15	(10)	Establish, coordinate, and manage a program to provide
16		a means for public access to public information and
17	·	develop and operate an information network in
18		conjunction with its overall plans for establishing a
19		communication backbone for state government.
20	(c)	The state communication system shall be established

- (d) The department may adopt rules as may be necessary or desirable for the operation and maintenance of public buildings, and for the operation and implementation of a program to provide a means for public access to the State's information network system and public information. The rules shall be adopted pursuant to chapter 91.
- (e) The King Kamehameha celebration commission shall be
 placed within the department of accounting and general services
 for administrative purposes. The functions, duties, and powers,
 subject to the administrative control of the comptroller, and
 the composition of the commission shall be as heretofore
 provided by law.

1	(f) The functions and authority heretofore exercised by
2	the comptroller, board of commissioners of public archives, the
3	archivist, the disposal committee, and the insurance management,
4	surplus property management, and central purchasing functions of
5	the bureau of the budget and the nonhighway functions of the
6	department of public works as heretofore constituted are
7	transferred to the department of accounting and general services
8	established by this chapter.
9	(g) The department of accounting and general services
10	shall be responsible for preserving and protecting Washington
11	Place, including the grounds, and the historic residence
12	situated on its premises at Miller and Beretania streets in
13	Honolulu. The department shall administer, manage, operate, and
14	maintain Washington Place, and the trust fund created under
15	subsection (h).
16	(h) There is established a trust fund in the state
17	treasury to be known as the Washington Place trust fund, into
18	which shall be deposited:
19	(1) All rents and fees collected for the use of Washington
20	Place and from activities conducted on the premises;
21	(2) All other money donated or received from all other
