### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 6. All unexpended and unencumbered balances of the
- 2 appropriations made in this Act as of the close of business on
- 3 June 30, 2014, shall lapse.
- 4 SECTION 7. If any provision of this Act, or the
- 5 application thereof to any person or circumstance is held
- 6 invalid, the invalidity does not affect other provisions or
- 7 applications of the Act, which can be given effect without the
- 8 invalid provision or application, and to this end the provisions
- 9 of this Act are severable.
- 10 SECTION 8. This Act shall take effect upon its approval.
