13	shall obtain the approval of the attorney general before payment
14	of any claim can be made.
15	SECTION 5. Notwithstanding the sums hereinabove stated as
16	interest upon judgments against the State, payment of interest
17	shall be limited to the period from the date of judgment, if
18	applicable, to thirty days after the effective date of this Act,
19	as provided in section 662-8, Hawaii Revised Statutes, for those
20	cases to which the statute applies.
21	SECTION 6. All unexpended and unencumbered balances of the
22	appropriations made in this Act as of the close of business on
23	June 30, 2014, shall lapse.

- 1 SECTION 7. If any provision of this Act, or the
- 2 application thereof to any person or circumstance is held
- 3 invalid, the invalidity does not affect other provisions or
- 4 applications of the Act, which can be given effect without the
- 5 invalid provision or application, and to this end the provisions
- 6 of this Act are severable.
- 7 SECTION 8. This Act shall take effect upon its approval.
