# A BILL FOR AN ACT

MAKING APPROPRIATIONS FOR COLLECTIVE BARGAINING COST ITEMS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 PART I

2 SECTION 1. There are appropriated or authorized from the  
3 sources of funding indicated below to departmental  
4 administration and budget division (BUF 101) the following sums,  
5 or so much thereof as may be necessary, to fund for fiscal  
6 biennium 2013-2015 all collective bargaining cost items in the  
7 agreement negotiated with the exclusive bargaining  
8 representative of collective bargaining unit (1):

16 SECTION 11. Salary increases and cost adjustments provided  
 17 in this Act for any officer or employee whose compensation is  
 18 paid, in whole or in part, from federal, special, or other funds  
 19 shall be paid wholly or proportionately, as the case may be,  
 20 from the respective funds.

21 SECTION 12. Funds appropriated or authorized by this Act  
 22 that are not expended or encumbered by June 30, 2014, and



1 June 30, 2015, of the respective fiscal years, shall lapse as of  
2 those dates.

3 SECTION 13. This Act, upon its approval, shall take effect  
4 on July 1, 2050.
