# A BILL FOR AN ACT

MAKING APPROPRIATIONS FOR COLLECTIVE BARGAINING COST ITEMS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 PART I

2 SECTION 1. There are appropriated or authorized from the  
3 sources of funding indicated below to departmental  
4 administration and budget division (BUF 101) the following sums,  
5 or so much thereof as may be necessary, to fund for fiscal  
6 biennium 2013-2015 all collective bargaining cost items in the  
7 agreement negotiated with the exclusive bargaining  
8 representative of collective bargaining unit (5):

 13 adjustments authorized by chapter 89C, Hawaii Revised Statutes,  
 14 for state officers and employees who are excluded from  
 15 collective bargaining and belong to the same compensation plans  
 16 as those officers and employees within collective bargaining  
 17 unit (5):

16 shall be paid wholly or proportionately, as the case may be,  
17 from the respective funds.

18 SECTION 6. Funds appropriated or authorized by this Act  
19 that are not expended or encumbered by June 30, 2014, and June  
20 30, 2015, of the respective fiscal years, shall lapse as of  
21 those dates.



1 SECTION 7. This Act, upon its approval, shall take effect  
2 on July 1, 2050.
