JUSTIFICATION SHEET

DEPARTMENT: Taxation

TITLE: A BILL FOR AN ACT RELATING TO THE DEPARTMENT OF TAXATION SPECIAL ENFORCEMENT SECTION.

PURPOSE: To repeal the sunset date in the act creating the Department of Taxation's Special Enforcement Section.

MEANS: Amend section 13 of Act 134, Session Laws of Hawaii 2009.

JUSTIFICATION: The Special Enforcement Section is a valuable enforcement and education tool for the Department. Through its efforts, the section has generated almost \$1,000,000 in taxes with a reduced staffing level of three employees.

More importantly, the staff has educated cash-based businesses about their tax obligations and the requirement that all taxpayers should pay their fair share of taxes. This is especially important in a state which is mostly composed of small businesses, as many small businesses start off as a cash-based business.

In addition to the promoting tax education among the small businesses, the section has helped to identify other issues and cases for enforcement by the Department.

Impact on the public: The continued activity of the Special Enforcement Section will further educate taxpayers on their responsibilities under the law.

Impact on the department and other agencies: Continued activity by the Special Enforcement Section will increase taxes collected by the Department.
