A BILL FOR AN ACT

RELATING TO NATIVE WILDLIFE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Hawaii has the 2 largest concentration of endangered and threatened species in 3 the world, a majority of which are birds. Of more than one 4 hundred types of endemic Hawaiian birds, more than two-thirds 5 are already extinct and over eighty per cent of those that 6 remain are threatened with extinction. Furthermore, there are 7 more than fourteen million seabirds that rely on habitats in the 8 Hawaiian archipelago. It is imperative that the State protect 9 these endangered and endemic animals if an oil or fuel-related 10 disaster affecting native wildlife were to occur.
- 11 The legislature finds that the Hawaii Wildlife Center's
- 12 mission is to conserve Hawaii's native wildlife through
- 13 emergency response, rehabilitation, education, and research.
- 14 The Center is the only native wildlife emergency response and
- 15 rehabilitation facility in the State and in the Pacific Island
- 16 region. In addition, the Center is the only facility within the
- 17 State that meets all federal and state standards for
- 18 accommodating a large-scale rescue and rehabilitation effort HB988 HD2 HMS 2013-2308



- 1 targeting sick, injured, or oiled wildlife. A purpose-built and
- 2 operational oiled-wildlife response facility is the standard set
- 3 for highly successful emergency responses as it provides
- 4 efficient, state-of-the-art wildlife care, control of animal and
- 5 hazardous waste handling and tracking, and ensures the safety of
- 6 everyone working with oiled wildlife. Also, the Center serves
- 7 as a critical emergency response facility for the training of
- 8 response personnel and volunteers and for the rehabilitation of
- 9 injured, sick, and contaminated wildlife throughout the Pacific
- 10 Islands region.
- 11 The purpose of this Act is to increase the environmental
- 12 response, energy, and food security tax to support the
- 13 operations of an environmental disaster standby and response
- 14 facility to respond to oil and fuel-related disasters affecting
- 15 native wildlife in the State.
- 16 SECTION 2. Chapter 195D, Hawaii Revised Statutes, is
- 17 amended by adding a new section to be appropriately designated
- 18 and to read as follows:
- 19 "S195D- Wildlife recovery and rehabilitation special
- 20 fund. (a) There is created within the state treasury the
- 21 wildlife recovery and rehabilitation special fund, which shall

The tax shall be [\$1.05] \$ on each barrel or fractional part of 2 3 a barrel of petroleum product that is not aviation fuel; 4 provided that of the tax collected pursuant to this 5 subsection[+] the first \$ shall be deposited into the 6 wildlife recovery and rehabilitation special fund established 7 under section 195D- , and thereafter: 8 (1) 5 cents of the tax on each barrel shall be deposited 9 into the environmental response revolving fund 10 established under section 128D-2; 11 (2) 15 cents of the tax on each barrel shall be deposited 12 into the energy security special fund established under section 201-12.8; 13 10 cents of the tax on each barrel shall be deposited 14 (3) 15 into the energy systems development special fund 16 established under section 304A-2169; and 17 (4)15 cents of the tax on each barrel shall be deposited 18 into the agricultural development and food security 19 special fund established under section 141-10. 20 The tax imposed by this subsection shall be paid by the distributor of the petroleum product." 21

- SECTION 4. Section 243-3.5, Hawaii Revised Statutes, is 1 2 amended as follows: 3 1. By amending subsection (a) to read: 4 In addition to any other taxes provided by law, 5 subject to the exemptions set forth in section 243-7, there is 6 hereby imposed at times provided in section 128D-2 a state 7 environmental response tax of [5] 7 cents on each barrel or 8 fractional part of a barrel of petroleum product sold by a 9 distributor to any retail dealer or end user, other than a 10 refiner, of petroleum product; provided that cents of the 11 tax on each barrel shall be used pursuant to section 128D-2 to 12 address concerns relating to drinking water[-] and \$ 13 the tax revenues shall be deposited into the wildlife recovery and rehabilitation special fund established pursuant to section 14 15 195D- . The tax imposed by this subsection shall be paid by the distributor of the petroleum product." 16 17 2. By amending subsection (c) to read: 18 "(c) Notwithstanding section 248-8 to the contrary, the 19 environmental response tax collected under this section shall be 20 paid over to the director of finance for deposit into the 21 environmental response revolving fund established by section
 - 128D-2[-] except as provided in subsection (a)."
