
HOUSE CONCURRENT RESOLUTION

URGING THE DEPARTMENT OF AGRICULTURE TO ESTABLISH A PROGRAM TO
AWARD GRANTS TO FARMERS WHO IMPLEMENT NATURAL FARMING.

1 WHEREAS, global natural farming is an agricultural method
2 developed and refined over the past 50 years by Han Kyu Cho of
3 the Republic of Korea; and
4

5 WHEREAS, in more than 30 countries worldwide, global
6 natural farming techniques have been demonstrated as a viable
7 method of agricultural production without the use of
8 conventional and imported pesticides and fertilizers; and
9

10 WHEREAS, as a distinctive approach to organic farming,
11 global natural farming uses local natural farm resources and
12 indigenous microorganisms and involves the propagation of
13 mycorrhizae along with adding specific nutritional inputs during
14 critical growth stages of plants; and
15

16 WHEREAS, the global natural farming methodology is not only
17 safe for the environment, but actually rehabilitates the ecology
18 of an area; and
19

20 WHEREAS, there are currently six acres of land in Waianae,
21 Oahu, being used for the natural farming of Vietnamese Taro and
22 Thai basil and since the project began in June 2010, the product
23 quality has improved, product yield has increased, and
24 production costs and water consumption have decreased; and

26 WHEREAS, Hawaii would benefit greatly by the propagation of
27 this agricultural methodology; now, therefore,

29 BE IT RESOLVED by the House of Representatives of the

 8 intend to implement the Cho global natural farming methodology

 13 Board of Agriculture.
