
HOUSE CONCURRENT RESOLUTION

URGING THE DEPARTMENT OF COMMERCE AND CONSUMER AFFAIRS AND THE
HAWAII PSYCHOLOGICAL ASSOCIATION TO DEVELOP DRAFT
LEGISLATION ESTABLISHING, IMPLEMENTING, AND MONITORING
CONTINUING EDUCATION REQUIREMENTS FOR ALL LICENSED
PSYCHOLOGISTS IN HAWAII.

1 WHEREAS, the profession of psychology provides critically
2 needed services in prevention, intervention, and treatment to a
3 broad spectrum of clients; and
4

5 WHEREAS, it is vitally important that psychologists provide
6 the best possible service to their clients; and
7

8 WHEREAS, continuing education is essential to help
9 psychologists maintain their professional competency and keep
10 abreast of the latest developments in their profession; and
11

12 WHEREAS, Hawaii is one of only six states that do not
13 require continuing education credits as part of their licensing
14 law for psychologists; and
15

16 WHEREAS, the American Psychological Association is a
17 membership organization that represents approximately 84,000
18 psychologists across the nation, and the Hawaii chapter
19 represents about 300 psychologists across the State; and

21 WHEREAS, the Department of Commerce and Consumer Affairs is
22 charged with protecting consumers through its regulatory and
23 licensing responsibilities; and

25 WHEREAS, the Board of Psychology recommends that the Hawaii
26 Psychological Association complete the Department of Commerce
27 and Consumer Affairs Professional and Vocational Licensing
28 Division's Continuing Professional Education Guidelines
29 Checklist; and



1 WHEREAS, the Department of Commerce and Consumer Affairs
2 and Hawaii Psychological Association are currently working
3 together on specific provisions to be included in a bill to
4 establish continuing education requirements for licensed
5 psychologists; and

7 WHEREAS, the Department of Commerce and Consumer Affairs
8 and Hawaii Psychological Association have also identified issues
9 relevant to the requirements for continuing education for
10 licensed psychologists, such as:

- 12 (1) Ensuring that such requirements do not impose an undue
13 burden on psychologists in rural areas of Hawaii;

 - 15 (2) Using an established, widely recognized non-
16 governmental entity to approve continuing education
17 credits; and

 - 19 (3) Ensuring that the program to implement and monitor
20 continuing education credits for licensed
21 psychologists is cost-neutral to the State; and

23 WHEREAS, there are currently opportunities offered by
24 approved providers for continuing education statewide, including
25 in rural areas, such as in-person courses, webinars, and
26 teleconferences; and

28 WHEREAS, continuing education opportunities should be made
29 available to members and non-members of the Hawaii Psychological
30 Association; and

32 WHEREAS, the joint effort of the Department of Commerce and
33 Consumer Affairs and Hawaii Psychological Association is
34 critical in increasing and maintaining the professional
35 competence of licensed psychologists in Hawaii through a
36 continuing education program; now, therefore,

38 BE IT RESOLVED by the House of Representatives of the
39 Twenty-seventh Legislature of the State of Hawaii, Regular
40 Session of 2013, the Senate concurring, that the Department of
41 Commerce and Consumer Affairs and Hawaii Psychological
42 Association are urged to continue collaborating on the issue of
43 developing, implementing, and monitoring continuing education
44 requirements for all licensed psychologists in Hawaii; and



1 BE IT FURTHER RESOLVED that the Hawaii Psychological
2 Association is urged to complete the Department of Commerce and
3 Consumer Affairs Professional and Vocational Licensing
4 Division's Continuing Professional Education Guidelines
5 Checklist; and

7 BE IT FURTHER RESOLVED that no later than 20 days prior to
8 the convening of the Regular Session of 2014, the Department of
9 Commerce and Consumer Affairs and Hawaii Psychological
10 Association are requested to submit to the Legislature a
11 proposed draft for a bill to establish, implement, and monitor
12 continuing education requirements for all licensed psychologists
13 in Hawaii; and

15 BE IT FURTHER RESOLVED that certified copies of this
16 Concurrent Resolution be transmitted to the Director of Commerce
17 and Consumer Affairs and President of the Hawaii Psychological
18 Association.
