## HOUSE CONCURRENT RESOLUTION

## REQUESTING A FINANCIAL AND MANAGEMENT AUDIT OF THE ADMINISTRATION OF THE UNIVERSITY OF HAWAII.

WHEREAS, on November 19, 2012, the Senate Special Committee 1 2 on Accountability - 02 issued a report regarding the oversight, accountability, and transparency of the operational and 3 4 financial management of the University of Hawaii System, including but not limited to the University of Hawaii's Athletic 5 Department; and 6 7 8 WHEREAS, the report heavily criticized the administration 9 of the University and its Board of Regents; and 10 WHEREAS, the Special Committee's report revealed that the 11 potential problems within the University extended beyond the 12 13 initial deposit, such as: 14 A procedurally and fiscally questionable settlement 15 (1)and reassignment of duty of the University's Athletic 16 Director to a new position with a \$211,000 annual 17 18 salary; 19 The payment of up to \$90,000 to a search firm to 20 (2) conduct a search for a new Athletic Director; 21 22 23 (3) The failure of the Board of Regents to comply with 24 open meetings law; 25 26 (4) The redaction of public records in violation of open records law; and 27 28 The hiring of outside counsel in possible violation of 29 (5) procurement requirement law; and 30

1 WHEREAS, the Special Committee's report also noted that the 2 University's previous buyouts of contracts appeared to "reward individuals for inadequate performance"; now, therefore, 3 4 BE IT RESOLVED by the House of Representatives of the 5 6 Twenty-seventh Legislature of the State of Hawaii, Regular Session of 2013, the Senate concurring, that the Auditor is 7 requested to perform a financial and management audit of the 8 9 administration of the University of Hawaii and its Board of 10 Regents; and 11 BE IT FURTHER RESOLVED that while the audit should focus on 12 13 the specific concerns raised in the Special Committee's report, 14 the Auditor is free to examine related issues that the Auditor determines are necessary to properly audit the administration of 15 the University of Hawaii and its Board of Regents; and 16 17 BE IT FURTHER RESOLVED that the Auditor is requested to 18 19 submit a report of any findings and recommendations to the 20 Legislature no later than twenty days prior to the convening of 21 the Regular Session of 2016; and 22 23 BE IT FURTHER RESOLVED that certified copies of this Concurrent Resolution be transmitted to the Auditor, the 24 25 Chairperson of the Board of Regents of the University of Hawaii, and the President of the University of Hawaii. 26 27 28 29 OFFERED BY:
