
HOUSE CONCURRENT RESOLUTION

REQUESTING THE EXTENSION OF THE GOVERNMENT CONTRACTING TASK FORCE TO DEVELOP RECOMMENDATIONS TO ADDRESS ISSUES THAT AFFECT PROCUREMENT FOR GOODS AND SERVICES PURCHASED THROUGH NONPROFIT ORGANIZATIONS, INCLUDING HUMAN SERVICE NONPROFIT ORGANIZATIONS THAT DELIVER PIVOTAL GOODS AND SERVICES TO INDIVIDUALS, FAMILIES, COMMUNITIES, AND OTHER SMALL BUSINESSES.

1 WHEREAS, nationally, state and local governments contract
2 with nonprofit organizations--particularly human service
3 organizations--to deliver pivotal services to individuals,
4 families, and communities; and
5

6 WHEREAS, in October 2010, the Urban Institute released
7 three related reports, including one titled "National Study of
8 Nonprofit-Government Contracting, State Profiles", which
9 outlined a variety of problems faced by these nonprofits; and
10

11 WHEREAS, key problems included payments that fail to cover
12 full program costs, complex and time-consuming applications and
13 reporting, changes to contractual and grant agreements, and late
14 payments; and
15

16 WHEREAS, in Hawaii, one hundred sixty-one human service
17 nonprofit organizations provided services to state and county
18 government in 2009, and fifty per cent of the nonprofit
19 organizations reported problems with late payments, which is
20 substantially higher than the national average of forty-one per
21 cent; and

23 WHEREAS, small businesses that contract with government
24 agencies report the same concerns and face the same negative
25 consequences, and both nonprofit organizations and businesses
26 struggle to make ends meet in an economy that has faltered; and

1 WHEREAS, upon adoption of Senate Concurrent Resolution No.
2 28, S.D. 2, in 2011, the Comptroller established a prompt
3 payment task force and invited the initial members of the task
4 force; and

5
6 WHEREAS, upon adoption of Senate Concurrent Resolution No.
7 40, S.D. 1, H.D. 1 in 2012, the prompt payment task force was
8 renamed the government contracting task force, had its term
9 extended, and its scope narrowed; and

10
11 WHEREAS, the government contracting task force has held at
12 least four meetings since September 2012; and

13
14 WHEREAS, while the government contracting task force
15 identified a number of areas of concern, the members have
16 determined that further work by the task force is necessary to
17 complete the tasks requested in Senate Concurrent Resolution No.
18 40, S.D. 1, H.D. 1 (2012); and

20 WHEREAS, in addition, recommendations of the task force
21 will benefit from pilot projects involving the use of
22 "dashboard" and other information technology infrastructure
23 enhancements proposed for implementation in 2013; now,
24 therefore,

26 BE IT RESOLVED by the House of Representatives of the
27 Twenty-seventh Legislature of the State of Hawaii, Regular
28 Session of 2013, the Senate concurring, that the government
29 contracting task force is extended until December 31, 2013; and

31 BE IT FURTHER RESOLVED that all members of the government
32 contracting task force are invited to remain and serve as
33 members and that the chairperson of the task force may invite
34 other members; and

36 BE IT FURTHER RESOLVED that the government contracting task
37 force is requested to finalize recommendations that were
38 initially recommended in the task force's 2012 interim report to
39 the 2013 legislature to address issues that affect procurement
40 for goods and services purchased through nonprofit
41 organizations, including human service nonprofit organizations
42 that deliver pivotal goods and services to individuals,
43 families, communities, and other small businesses; and

1 BE IT FURTHER RESOLVED that in finalizing these
2 recommendations, the government contracting task force is
3 requested to:

4
5 (1) Report on its examination of state contracting
6 processes, from the initial planning phase through
7 service delivery, and issues relating to payment when
8 invoices are submitted;

9
10 (2) Make recommendations on processes that can be
11 simplified and standardized between government
12 agencies, the State Procurement Office, the Department
13 of Accounting and General Services, the Department of
14 the Attorney General, and the parties contracted to
15 deliver services; and

17 (3) Evaluate the "dashboard" demonstration project that
18 utilizes designated contract areas in the Department
19 of Health, Department of Human Services, and
20 Department of Public Safety to test business process
21 improvements or other approaches and make
22 recommendations to streamline the contracting process,
23 with the goal of clarifying problem areas and
24 solutions for government agencies and the parties
25 contracted to provide services; and

27 BE IT FURTHER RESOLVED that the government contracting task
28 force is requested to submit a report of its findings and
29 recommendations to the Legislature no later than December 31,
30 2013; and
31

32 BE IT FURTHER RESOLVED that the government contracting task
33 force, upon the request of the Legislature, participate in a
34 joint informational briefing to discuss its report; and

36 BE IT FURTHER RESOLVED that certified copies of this
37 Concurrent Resolution be transmitted to the Chief of Staff,
38 Office of the Governor; Chief Information Officer; Attorney
39 General; Comptroller; Administrator of the State Procurement
40 Office, Department of Accounting and General Services; Director
41 of Finance; Director of Health; Director of Human Services;
42 Chairperson of the Board of Directors of the Hawaii Alliance of
43 Nonprofit Organizations; President of the Building Industry
44 Association of Hawaii; Executive Director of The Pacific



1 Resource Partnership; President of The Chamber of Commerce of
2 Hawaii; Chairperson of the Senate Committee on Economic
3 Development, Government Operations and Housing; Chairperson of
4 the Senate Committee on Human Services; Chairperson of the
5 Senate Committee on Public Safety, Intergovernmental and
6 Military Affairs; Chairperson of the House of Representatives
7 Committee on Economic Development and Business; Chairperson of
8 the House of Representatives Committee on Human Services;
9 Chairperson of the House of Representatives Committee on Public
10 Safety and Military Affairs; and Chairperson of the House of
11 Representatives Committee on Veterans, Military, & International
12 Affairs, & Culture and the Arts.
