
HOUSE CONCURRENT RESOLUTION

URGING ALL HEALTH CARE PROVIDERS IN HAWAII THAT PERFORM ORGAN
TRANSPLANTATION TO CONSIDER PLACING HIV-POSITIVE PATIENTS
WHO NEED AN ORGAN TRANSPLANT ON AN ORGAN TRANSPLANT
WAITLIST.

1 WHEREAS, there were 2,425 people in Hawaii living with HIV
2 or AIDS in 2011; and

3
4 WHEREAS, the number of people in Hawaii living with HIV has
5 increased every year since 2001, in part, due to the use of a
6 combination of drugs, known as highly active antiretroviral
7 therapy, to suppress HIV; and

8
9 WHEREAS, today, most people infected with HIV who use
10 highly active antiretroviral therapy tend to die from end-stage
11 organ disease and organ failure that result from chronic
12 conditions rather than AIDS-associated opportunistic infections;
13 and

14
15 WHEREAS, in the event of organ failure, an organ
16 transplant, typically of a liver or kidney, is often an HIV-
17 positive person's only chance of survival; and

18
19 WHEREAS, there are three hundred ninety-one people in
20 Hawaii waiting for a liver or kidney transplant; and

21
22 WHEREAS, health care facilities on the mainland currently
23 perform kidney and pancreas transplants on HIV-positive patients
24 who have end-stage kidney disease and diabetes; and

25
26 WHEREAS, recent research has shown that HIV-positive
27 patients who received a kidney transplant experienced a 94.6%
28 one-year survival rate and a 88.2% three-year survival rate,
29 which were similar to kidney transplant recipients who were not

1 infected with HIV and higher than kidney transplant recipients
2 who were age sixty-five and older; and
3

4 WHEREAS, under certain circumstances, HIV-positive patients
5 are good candidates for organ transplantation and have positive
6 post-transplant outcomes, and there is no reason to deny HIV-
7 positive patients an organ transplant solely due to their HIV
8 status; now, therefore,

10 BE IT RESOLVED by the House of Representatives of the
11 Twenty-seventh Legislature of the State of Hawaii, Regular
12 Session of 2013, the Senate concurring, that all health care
13 providers in Hawaii that perform organ transplantation are urged
14 to consider placing HIV-positive patients who need an organ
15 transplant on an organ transplant waitlist; and

17 BE IT FURTHER RESOLVED that certified copies of this
18 Concurrent Resolution be transmitted to the Director of Health
19 who in turn is requested to transmit copies to the chief
20 executive officers of all health care providers in the State
21 that perform organ transplantation; and the Executive Director
22 of Legacy of Life.
