# HOUSE RESOLUTION

SUPPORTING THE AEGIS BALLISTIC MISSILE DEFENSE SYSTEM AND THE  
GROUND-BASED MIDCOURSE DEFENSE SYSTEM.

1           WHEREAS, Hawaii is a world leader in uniting countries in  
2 peace and harmony through the spirit of kokua and aloha and  
3 through its leadership, participation, efforts, and commitment  
4 to improve the quality of life enjoyed by all; and  
5

6           WHEREAS, in 1960, the aloha spirit played a key role in  
7 convincing the United States Congress to establish the twenty-  
8 one acre East-West Center, located adjacent to the University of  
9 Hawaii at Manoa, midway between Asia and the United States  
10 mainland; and  
11

12           WHEREAS, the East-West Center hosted the Asia Pacific  
13 Economic Cooperation in November 2011, where the twenty-one  
14 member body assembled in Hawaii to discuss transpacific  
15 strategic economic partnerships, regional economic integration,  
16 climate change, food safety, and food security; and  
17

18           WHEREAS, Hawaii is also the epicenter of the Pacific Rim  
19 and home to the United States Pacific Command Headquarters,  
20 established in 1947; and  
21

22           WHEREAS, Hawaii has hosted the Rim of the Pacific Exercise,  
23 which has brought together the navies from throughout the  
24 Pacific Rim in a collaborative effort to share their respective  
25 expertise; and  
26

27           WHEREAS, the Aegis Ballistic Missile Defense System is the  
28 foundation of the sea-based ballistic missile defense for the  
29 Unites States, Japan, Spain, Norway, the Republic of Korea, and  
30 the North Atlantic Treaty Organization; and  
31

32           WHEREAS, the Air Defense Artillery Missile Defense System  
33 is the foundation of land-based ballistic missile defense for  
34 Japan, the Republic of Korea, Taiwan, the United Arab Emirates,



1 Qatar, Bahrain, Kuwait, Saudi Arabia, Turkey, Israel, Germany,  
2 Netherlands, and the North Atlantic Treaty Organization; and  
3

4 WHEREAS, the Aegis Ballistic Missile Defense System and the  
5 Air Defense Artillery Missile Defense System have effectively  
6 served to deter aggression from other countries; and  
7

8 WHEREAS, the Ground-Based Midcourse Defense System and its  
9 Ground Based Interceptor missiles in Alaska and California and  
10 sensors located around the Pacific Rim, including the Sea-based  
11 X-band Radar stationed in Hawaii, Aegis Ballistic Missile  
12 Defense ships ported in Hawaii, and radars located in Alaska and  
13 Japan, in conjunction with the Missile Defense Integration and  
14 613th Air and Space Operations Center located at Hickam Air  
15 Force Base, function as key components of the integrated United  
16 States Ballistic Missile Defense System; and  
17

18 WHEREAS, the Pacific Missile Range Facility on Kauai plays  
19 a critical role in the development and testing of the United  
20 States and allied nations' missile defense systems and serves to  
21 defend the United States, including Hawaii, Alaska, and the  
22 Pacific Rim, against long-range ballistic missiles; and  
23

24 WHEREAS, due to Hawaii's geographical proximity to the  
25 Democratic People's Republic of Korea, military preparedness and  
26 defensive action are key in deterring aggression, preserving  
27 peace, safeguarding freedom, and protecting the United States  
28 and its citizens; and  
29

30 WHEREAS, on December 12, 2012, the Democratic People's  
31 Republic of Korea conducted a successful long-range ballistic  
32 missile test and on February 12, 2013, conducted a nuclear  
33 weapons test; and  
34

35 WHEREAS, the United Nations has increased sanctions against  
36 the Democratic People's Republic of Korea as a means to prevent  
37 further testing of their nuclear arms and long-range missile  
38 capabilities; now, therefore,

1 BE IT RESOLVED by the House of Representatives of the  
2 Twenty-seventh Legislature of the State of Hawaii, Regular  
3 Session of 2013, that this body acknowledges, supports, and  
4 commends the achievements of the Aegis Ballistic Missile Defense  
5 System and the Ground-Based Midcourse Defense System and  
6 expresses its gratitude for the protection and freedoms these  
7 systems and the people who manage them provide to the people of  
8 the State; and

10 BE IT FURTHER RESOLVED that certified copies of this  
11 Resolution be transmitted to the President of the United States,  
12 the members of Hawaii's congressional delegation, the Governor,  
13 the Lieutenant Governor, and the Adjutant General.
