HOUSE RESOLUTION

URGING THE DEPARTMENT OF COMMERCE AND CONSUMER AFFAIRS AND THE AMERICAN ASSOCIATION FOR MARRIAGE AND FAMILY THERAPY: HAWAII DIVISION, TO DEVELOP DRAFT LEGISLATION ESTABLISHING, IMPLEMENTING, AND MONITORING CONTINUING EDUCATION REQUIREMENTS FOR ALL LICENSED MARRIAGE AND FAMILY THERAPISTS IN HAWAII.

WHEREAS, the profession of marriage and family therapy 1 provides critically needed services in prevention, intervention, 2 3 and treatment to a broad spectrum of clients; and 4 WHEREAS, it is vitally important that marriage and family 5 therapists provide the best possible service to their clients; 6 7 and 8 WHEREAS, continuing education is essential to help marriage 9 and family therapists maintain their professional competency and 10 keep abreast of the latest developments in their profession; and 11 12 WHEREAS, Hawaii is one of only three states that do not 13 require continuing education credits as part of their licensing 14 law for marriage and family therapists; and 15 16 WHEREAS, the American Association for Marriage and Family 17 Therapy is a membership organization that represents 18 approximately 25,000 marriage and family therapists across the 19 nation, and the Hawaii Division represents about 360 marriage 20 and family therapists across the State; and 21 22 WHEREAS, the Department of Commerce and Consumer Affairs is 23 charged with protecting consumers through its regulatory and 24 licensing responsibilities; and 25 26 WHEREAS, the Department of Commerce and Consumer Affairs 27 recommends that the American Association for Marriage and Family 28 Therapy: Hawaii Division complete the Department of Commerce and 29 Consumer Affairs, Professional and Vocational Licensing 30 Division's Continuing Professional Education Guidelines 31 Checklist; and 32
